Human flagging is prohibited. Flagging to support aerial application is limited to use of Global Positioning System (GPS) or mechanical flaggers.

User Safety Recommendations:

This pesticide is extremely toxic to aquatic organisms, including fish and aquatic invertebrates. Runoff from treated areas or deposition of spray droplets into a body of water may be hazardous to fish and aquatic invertebrates.

This product is highly toxic to bees exposed to direct treatment on blooming crops or weeds. PHYSICAL AND CHEMICAL HAZARDS

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

Application is prohibited directly into sewers or drains, or to any area like a gutter where drainage to sewers, storm drains, water bodies, or aquatic habitat can occur.

For use only by federal, state, tribal, or local government officials responsible for public health or vector control, or by persons certified in the appropriate category or otherwise authorized by the state or tribal lead pesticide regulatory agency to perform adult mosquito control applications, or by persons under their direct supervision.

Note: Before making the first application in a season, it is advisable to consult with the state or tribal agency with primary responsibility for pesticide regulation to determine if other regulatory requirements exist.

RESTRICTIONS:

- DO NOT use in outdoor residential misting systems.
- DO NOT use in metered release misting devices.
- DO NOT contaminate cropland (other than crops listed) or potable water supplies with spray drift.
- Not for indoor application.

RESISTANCE MANAGEMENT

For resistance management, MASTERLINE KONTROL 31-67 CONCENTRATE contains a Group 3A

insecticide. Any insect population may contain individuals naturally resistant to **MASTERLINE KONTROL 31-67 CONCENTRATE** and other Group 3A insecticides. The resistant individuals may dominate the insect/mite population if this group of insecticides/acaricides are used repeatedly in the same fields. Appropriate resistance-management strategies should be followed.

To delay insecticide/acaricide resistance, take the following steps:

- Rotate the use of **MASTERLINE KONTROL 31-67 CONCENTRATE** or other Group 3A insecticides within a growing season, or among growing seasons, with different groups that control the same pests.
- Adopt an integrated pest management program for insecticide/acaricides use that includes scouting, uses historical information related to pesticide use, crop rotation, record keeping, and which considers cultural, biological, and other chemical control practices.
- Monitor after application for unexpected target pest survival. If the level of survival suggests the
 presence of resistance, consult with your local university specialist or certified pest control
 advisor.
- Contact your local extension specialist or certified crop advisors for any additional pesticide resistance-management and/or IPM recommendations for the specific site and pest problems in your area.

MANDATORY SPRAY DRIFT MANAGEMENT

ULTRA LOW VOLUME APPLICATIONS

- Apply when ground wind speeds are equal to or greater than 1 mph.
- All types of applications should be conducted when temperatures at ground level are at or above 50°F.

For Ground Applications:

- Create an optimum swath when possible. An optimum swath width can be achieved when
 MASTERLINE KONTROL 31-67 CONCENTRATE is applied from a truck that is being driven
 perpendicular to the wind direction. Direct the spray head of equipment to ensure even
 distribution of the spray cloud throughout the area.
- FOR BEST RESULTS treat when mosquitoes or insects are most active and weather conditions are conducive to keeping the spray cloud in the air column close to the ground.
- An inversion of air temperatures and a light breeze is preferable. Application during the cooler hours of the night or early morning is recommended.

For Aerial Applications:

• Do not apply by fixed wing aircraft at a nozzle height less than 100 feet (30.5 m) above ground or canopy, or by helicopter at a height less than 75 feet (22.9 m) above the ground or canopy, unless specifically approved by the state or tribe based on public health needs.

Adult mosquito control applications should be limited to trained personnel.

- For use only by federal, state, tribal or local government officials responsible for public health or vector control or by persons certified in the appropriate category or otherwise authorized by the state or tribal lead pesticide regulatory Agency to perform adult mosquito control applications, or by persons under their supervision, or as allowed by state regulations for persons treating private property.
- This pesticide is extremely toxic to aquatic organisms. Runoff from treated areas or deposition of spray droplets into a body of water may be hazardous to aquatic organisms.
- Do not apply over bodies of water (lakes, rivers, permanent streams, natural ponds, commercial

fishponds, swamps, marshes, or estuaries), except when necessary to target areas where adult mosquitoes are present, and weather conditions will facilitate movement of applied material beyond the body of water to minimize incidental deposition into the water body. Do not contaminate bodies of water when disposing of equipment rinsate or wash waters.

- Before making the first application in a season, it is advisable to consult with the state or tribal Agency with primary responsibility for pesticide regulation to determine if other regulatory requirements exist.
- Do not treat a site with more than 0.007 lbs. of permethrin. per acre in a single application or in any 24-hour period. Do not exceed 0.18 lbs. of permethrin per acre in any site in one year. More frequent applications may be made to prevent or control a threat to public and/or animal health determined by a state, tribal or local health or vector control Agency on the basis of documented evidence of disease-causing agents in vector mosquitoes or the occurrence of mosquito-borne disease in animal or human populations, or if specifically approved by the state or tribe during a natural disaster recovery effort.

CONDITIONS AND RATES TO USE FOR MOSQUITO CONTROL

MASTERLINE KONTROL 31-67 CONCENTRATE may be applied either diluted or undiluted as a thermal or non-thermal fog.

MASTERLINE KONTROL 31-67 CONCENTRATE is approved for application as an ultra low volume (ULV) non-thermal aerosol (cold fog) to control adult mosquitoes, flies, and gnats in residential and recreational areas where these insects are a problem, such as, but not limited to parks, campsites, woodlands, athletic fields, golf courses, residential areas, municipalities, gardens, playgrounds, recreational areas, and overgrown waste areas. For best results, treat when insects are most active and conditions are conducive to keeping the fog close to the ground.

Both ground and aerial applications should be made when meteorological conditions are conducive to keeping the spray cloud close to the ground, such as when an air temperature inversion is present. Applications during the cool hours of early morning or evening are preferable. Air temperatures should be greater than 50° F when conducting all types of applications. Application in calm air conditions is to be avoided. Apply only when ground wind speed is greater than 1 mph. Do not apply when wind speeds exceed 10 mph. Applications must not exceed the recommended rates.

Do not re-treat a site more than once in 3 days. Do not exceed 25 applications at 0.007 lbs. of permethrin per acre per application or 0.025 lbs. PBO per acre per application, or 0.18 lbs. of permethrin per acre per season or 2.0 lbs. PBO per acre per year. When rotating products with other insecticides containing piperonyl butoxide, do not exceed 2 lbs. PBO per acre per year. When targeting *Aedes Taeirorhynchus* and other difficult species applications of PBO may be made up to 0.08 lbs. PBO per acre.

More frequent treatments may be made to prevent or control a threat to public and/or animal health determined by a state, tribal or local health or vector control agency on the basis of documented evidence of disease causing agents in vector mosquitoes or the occurrence of mosquito-borne disease in animal or human populations, or if specifically approved by the state or tribe during a natural disaster recovery effort.

MASTERLINE KONTROL 31-67 CONCENTRATE can be applied over specific growing crops and range grasses prior to harvest for the control of adult mosquitoes and biting flies within or adjacent to these areas. Application can only be made where the following crops are present:

Watermelon (includes hybrids and/or varieties if Citrullus lanatus).

In the treatment of corrals, feedlots, animal confinements/houses, swine lots, poultry ranges and zoos, cover any exposed drinking water, drinking fountains and animal feed before application.

GROUND APPLICATION INSTRUCTIONS (Thermal and Non-Thermal Applications)

DROPLET SIZE CALIBRATION FOR GROUND APPLICATION EQUIPMENT: Spray equipment must be adjusted so that the volume median diameter is less than 30 microns (Dv $0.5 < 30 \mu m$) and that 90% of the spray is contained in droplets smaller than 48 microns (Dv $0.9 < 48 \mu m$). Directions from the equipment manufacturer or vendor, pesticide registrant or a test facility using a laser-based measurement instrument must be used to adjust equipment to produce acceptable droplet size spectra. Application

equipment must be tested at least annually to confirm that pressure at the nozzle and nozzle flow rate(s) are properly calibrated.

THERMAL AEROSOL FOGGING

TRUCK MOUNTED: Apply diluted or undiluted with suitable Thermal Fogging equipment. Do not exceed the maximum a.i./acre rates. May be applied at speeds of 5 to 20 mph, treating a 300 ft. swath. To reduce oil requirement and sludge buildup in equipment, use a suitable mineral oil of 60 – 100 second viscosity. For use with hand foggers, use the same a.i./acre rates and a swath width of 50 ft with a walking speed of 2 mph. Do not wet foliage since the oil base formulation may be phytotoxic. Do not fog when wind conditions exceed 10 miles per hour. Use well maintained and properly calibrated fogger.

NON-THERMAL AEROSOL (COLD FOG)

MASTERLINE KONTROL 31-67 CONCENTRATE Non-Thermal Aerosol (cold fog) Application: To control mosquitoes, midges, black flies, and other biting flies, apply MASTERLINE KONTROL 31-67 CONCENTRATE using any standard ULV ground applicator capable of producing a non-thermal aerosol spray. Apply the product undiluted at a flow rate of 1.0 to 6.00 ounces per minute at an average vehicle speed of 10 mph. If a different vehicle speed is used, adjust the rate accordingly. These rates are equivalent to 0.0035 to 0.021 pounds of permethrin and 0.0075 to 0.047 pounds of piperonyl butoxide per acre. Vary flow rates accordingly to vegetation density and mosquito population. Use higher flow rates in heavy vegetation or when populations are high. An accurate flow meter must be used to ensure the proper flow rate. MASTERLINE KONTROL 31-67 CONCENTRATE may also be applied by diluting with a suitable solvent such as mineral oil and applying so as not to exceed the maximum pounds of active ingredient per acre as shown in the first column of the following tables. The following charts represent some suggested dilution and application rates for ground ULV applications. If an alternative dilution rate is used, adjust the flow rate accordingly.

For proper ground application, mount the fog applicator so that the nozzle is at least 4 $\frac{1}{2}$ feet above ground level and directed out the back of the vehicle. Failure to follow the above directions may result in reduced effectiveness.

AS A BARRIER SPRAY USING A MISTER TYPE UNIT: For use in non-thermal equipment, apply MASTERLINE KONTROL 31-67 CONCENTRATE with a mist blower adjusted to deliver droplets with a volume median diameter_of $50-120\mu m$. Use undiluted or diluted to achieve an application of 0.00175/0.00376 # a.i./acre. Use a 50 ft (15.2m) swath while walking at a speed of 2 mph (3.2 kph). If using a different speed, swath, or dilution, do not exceed the maximum a.i./acre. When this product is applied as a barrier treatment, do not apply within 100 feet (30 meters) of lakes and streams.

AERIAL APPLICATION INSTRUCTIONS

The use of aircraft specially equipped and capable of applying ULTRA LOW VOLUMES of MASTERLINE KONTROL 31-67 CONCENTRATE may be necessary. Aerial applications should be done by suitable ULV equipment. Flow rate should be set so as to achieve 0.16 to 1.0 fluid ounces MASTERLINE KONTROL 31-67 CONCENTRATE per acre of the undiluted product. MASTERLINE KONTROL 31-67 CONCENTRATE may also be diluted with a suitable solvent such as mineral oil and applied by aerial ULV equipment so long as 1.0 fluid ounces per acre of MASTERLINE KONTROL 31-67 CONCENTRATE is not exceeded.

DROPLET SIZE CALIBRATION FOR AERIAL APPLICATION EQUIPMENT

Aerial Application made at <200 feet above ground elevation: Spray equipment must be adjusted so that the volume median diameter produced is less than 60 microns (Dv $0.5 < 60 \mu m$) and that 90% of the

spray is contained in droplets smaller than 100 microns (Dv $0.9 < 100 \ \mu m$). The effects of flight speed and, for non-rotary nozzles, nozzle angle on the droplet size spectrum must be considered. Directions from the equipment manufacturer or vendor, pesticide registrant or a test facility using a wind tunnel and laser based measurement instrument must be used to adjust equipment to produce acceptable droplet size spectra. Application equipment must be tested at least annually to confirm that pressure at the nozzle and nozzle flow rate(s) are properly calibrated.

Aerial Application made at >200 feet above ground elevation: Spray equipment must be adjusted so that the volume median diameter produced is less than 70 microns (Dv $0.5 < 70 \mu m$) and that 90% of the spray is contained in droplets smaller than 145 microns (Dv 0.9 < 145 microns). The effects of flight speed and, for non-rotary nozzles, nozzle angle on the droplet size spectrum must be considered. Directions from the equipment manufacturer or vendor, pesticide registrant or a test facility using a wind tunnel and laser-based measurement instrument must be used to adjust equipment to produce acceptable droplet size spectra. Application equipment must be tested at least annually to confirm that pressure at the nozzle and nozzle flow rate(s) are properly calibrated.

Do not apply by fixed wing aircraft at a height less than 100 feet, or by helicopter at a height less than 75 feet unless specifically approved by the state or tribe based on public health needs. Apply at a sufficient airspeed to deliver the appropriate amount of a.i./acre (from 0.00175 to 0.007 # a.i./acre) and to achieve the appropriate droplet range. Apply when wind speed is greater than 1 mph.

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal.

Pesticide Storage and Spill Procedures: Store upright at room temperature. Avoid exposure to extreme temperatures. In case of spill or leakage, soak up with an absorbent material such as sand, sawdust, earth, fuller's earth, etc. Dispose of with chemical waste.

Pesticide Disposal: Wastes resulting from the use of this product may be disposed of on site or at an approved waste disposal facility.

Container Disposal: Nonrefillable Container: Metal or Plastic Container. Do not reuse or refill container. Triple rinse or pressure rinse container (or equivalent) promptly after emptying. Offer for recycling, if available, or puncture and dispose of in a sanitary landfill, or by other procedures approved by state and local authorities, such as burning of plastic containers. If burned, stay out of smoke. Triple rinse as follows:

Containers 5 gallons or less: Empty the remaining contents into application equipment and drain for 10 seconds after the flow begins to drip. Fill the container ¼ full with mineral oil and recap. Shake for 10 seconds. Pour rinsate into mix tank or store rinsate for later use or disposal. Drain for 10 seconds after the flow begins to drip. Repeat this procedure two more times. Once cleaned, offer for recycling or reconditioning if appropriate, or puncture and dispose of in a sanitary landfill or by other procedures approved by State and local authorities. Do not cut or weld metal containers.

Containers larger than 5 gallons: Empty the remaining contents into application equipment. Fill the container ¼ full with mineral oil. Replace and tighten closures. Tip container on its side and roll back and forth, ensuring at least one complete revolution, for 30 seconds. Stand the container on its end and tip back and forth several times. Empty the rinsate into application equipment or a mix tank or store rinsate for later use or disposal. Repeat this procedure two more times. Once cleaned, offer for recycling or reconditioning if appropriate.

Refillable container: Refill this container with pesticide only. Do not reuse this container for any other purpose. Cleaning the container before final disposal is the responsibility of the person disposing of the container. Cleaning before refilling is the responsibility of the refiller.

Return container to point of purchase for reuse with seal intact and in salable condition. Before refilling, inspect thoroughly for damage such as cracks, punctures, bulges, dents, abrasions, and damaged or worn threads on closure devices. After filling and before transporting, check for leaks. Do not refill or transport damaged or leaking container.

To clean the container before final disposal, empty the remaining contents from the container into application equipment or mix tank. Fill the container about 10 percent full with mineral oil. Agitate

vigorously or recirculate mineral oil with pump for 2 minutes. Pour or pump rinsate into application equipment or rinsate collection system. Repeat this rinsing process two more times.
