To activate Ant Café RTU bait station; place station on a horizontal surface, deflect cone to the left, right, forward and back to break the seal on the inner ring allowing bait to flow into inner cone, saip off top of cone accounts of the inner nich entry port, apply a small amount of pressure to outer ring of bait station so that a small amount of liquid bait will flow out of the cone and into the valley created by the cone and outer ring. Place the bait station on a horizontal surface near ant activity. Place stations under food cabinets, sinks, stoves, refrigerators, food storage areas, attics, garages, basements, storage areas, closets, etc. Place on exterior windowsills and in doowage to help prevent entry of ants. Some bait stations may be designed to affixed to a wall, hung on pipes or branches, or placed on a flat surface

When using bait stations, wash hands thoroughly before hanging to remove any odors that may be repellent to ants, i.e. tobacco, garlic, strong chemicals/ cleaners etc.

Ant Café RTU Bait Station Instructions:

- 1. To activate Ant Café RTU, position vial so that red plug faces upwards.
- 2. To lock vial, thread serrated plastic string up through large square hole and then down through two smaller square holes.
- 3. Serrations on thread will engage and lock station closed.
- 4. Remove red plug and place bait station according to directions for use.
- 5. To refill bait station, disengage lock, open vial, and add additional bait. If bait has dried out, add additional water to rehydrate the bait. Alternatively, you may discard the old bait and add fresh bait. Follow disposal guidelines for proper disposal of used material.
- 6. Reengage lock and repeat steps 1-5 as necessary.
