On the basis of information furnished by the registrant in a submission dated 2/26/07, the above named pesticide is hereby conditionally registered under the Federal Insecticide, Fungicide and Rodenticide Act. Registration is in no way to be construed as an endorsement or recommendation of this product by the Agency. In order to protect health and the environment, the Administrator, on his motion, may at any time suspend or cancel the registration of a pesticide in accordance with the Act. The acceptance of any name in connection with the registration of a product under this Act is not to be construed as giving the registrant a right to exclusive use of the name or to its use if it has been covered by others.

The notice of registration dated December 11, 2001, is amended in accordance with FIFRA sec. 3(c)(7)(A) and (B) provided that:

1. You submit the data listed below:

In accordance with the attached efficacy review, you must submit confirmatory field data to support the claims for pharaoh and carpenter ants. These data are due to the ager cy within one year of the date of this amended notice of conditional registration.

2. You make the following label changes:

The Precautionary statements for eye irritation may be deleted in accordance with the toxicology review dated Dec 26, 2006. If you chose to retain them, they must read as follows in accordance with the Label Review Manual:

Causes moderate eye irritation. Avoid contact with eyes or clothing. Wash thoroughly with soap and water after handling and before eating, drinking, chewing gum or using tobacco.

Delete from the Precautionary Statements the following statements which detract from the First Aid Statements:

In case of contact immediately flush eyes with plenty of water. Get medical attention if irritation persists.

In accordance with the attached efficacy review, delete claims to kill or control fire ants or fire ant colonies. In addition, delete the claims "no ants" as this implies 100% efficacy.

Modify all ant claims as follows:

Kills the ant colony (except fire and harvester ant colonies).

Kills common household ants (except fire and harvester ants).

To control ants (except fire and harvester ants)...

Ants (except fire and harvester ants) are attracted to and will feed...

The ants (except fire and harvester ants) will return to their nests after consuming the bait and will feed their young and the queen destroying the colony (except fire and harvester ant colonies).

Since 275 gallon container is used only to transport the product between the mixing establishment and the packaging establishment, it may be deleted from the label in accordance with 40 CFR 152.30. A copy of the end use product label must accompany the 275 gallon container during transport in accordance with 40 CFR 152.30.

Delete the graphic showing food being served as it contradicts the directions "do not contaminate food or foodstuffs."

The name on the unit label must match the product name on the outside label.

Delete the statement "honeydew formula with unitract II. Honeydew is a food. The confidential appendix attached to this notice contains additional comments.

On the unit package, revise the statement referring the user to the label as follows: See accompanying package label for additional directions and precautions.

In the directions for opening the Ant and Roach Café, add the following: Do not use a kitchen knife.

In the directions listing where the product may be placed, delete "etc." as this may lead to product misuse.

Move the statement "Do not contaminate feed or foodstuffs" to the Directions for use, and revise it as follows:

Do not contaminate food, feed or foodstuffs.

The statement "Applicators must wear long-sleeved shirt and long pants, socks, shoes and gloves" may be deleted as the product is not labeled for agricultural use.

As you have boats and cruise ships on the label, the Environmental Hazards Statements must be revised as follows:

Do not apply directly to water, or to areas where surface water is present or to intertidal areas below the mean high water mark. Do not contaminate water when disposing of equipment washwater or rinsate.

A stamped copy of the label is enclosed for your records.

Submit two copies of the revised final printed label for the record.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA sec. 6(e). Your release for shipment of the product constitutes acceptance of these conditions.

A comment on the confidential statement of formula is contained in a confidential appendix attached to this notice.

DIRECTIONS FOR USE

It is a violation of federal law to use this product in a manner inconsistent with its labeling

Place baits in areas inaccessible to children and pets. To control ants and roaches use indoors or outdoors near homes, apartments, condominiums, schools, hospitals, restaurants, grocery stores, food processing plants, boats, cruise ships, institutional and commercial buildings, nursing homes, hotels and warehouses. Gourmet Liquid Ant Bait may be used at full strength, diluted with distilled water or other food grade liquid 1:1 to make a bait containing .5% actingredient. Bait may be used in Ant Café, Ant & Roach Café RTU, KmAntPro or other similar bait stations.

Ant & Roach Café RTU bait station Instructions: 1. To activate Ant & Roach Café RTU Bait Station, place station on a flat surface with the cone facing up. If cone is filled with liquid, move station from side to side rapidly and liquid will leave the cone. 2. With a knife or scissor cut the top of the cone, so that the top of the remaining cone is level with top of surrounding circular surface. 3 Place bait station according to label directions

Place the bait station on or near ant activity. Place stations under food cabinets, sinks, stoves, refrigerators, food storage areas, attics, garages, basements, storage areas, closets, etc. Place on exterior windowsills and ir doorways to help prevent entry of ants. Some bait stations may be designed to be affixed to a wall, hung on pipes or branches, anchored in the ground c placed on a flat surface. When using bait stations, wash hands thoroughly before handling to remove any odors that may be repellent to ants, i.e. tobacco, garlic, strong chemicals/ cleaners etc.

OPEN PLACEMENT METHOD NOT TO BE USED IN CALIFOF Gourmet Liquid ant Bait can be used to make small, pea sized placements and or long thin lines in areas where ants are a problem

Ants are attracted to and will feed on Gourmet Liquid Ant Bait until they die. The bait is designed to work slowly and sufficient bait should be made available for at least 14 days of continuous feeding. The ants will return to their nests after consuming the bait and will feed their young and the queen destroying the colony.

Repeat placement of the bait until satisfactory control has been achieved. Do not use sprays, foggers or any strong chemicals or cleaners near the ba containers or placements. This may contaminate the bait and cause the insects to cease feeding.


