PRECAUTIONARY STATEMENTS

DANGER - HAZARD TO HUMANS AND DOMESTIC ANIMALS

Corrosive: Causes irreversible eye damage and skin burns. May be fatal if inhaled. Harmful if swallowed or absorbed through skin. Do not get in eyes, on skin or clothing. Do not breathe dust, vapor or spray mist. Irritating to nose and throat. Wear goggles, face shield or safety glasses. Wash thoroughly with soap and water after handling. Remove contaminated clothing and wash before reuse.

FIRST AID:

ENVIRONMENTAL HAZARD

This pesticide is toxic to fish and aquatic organisms. Do not discharge effluent containing this product into lakes, streams, ponds, estuaries, oceans, or other waters unless in accordance with the requirements of a National Pollutant Discharge Elimination System (NPDES) permit and the permitting authority has been notified in writing prior to discharge. PHYSICAL OR CHEMICAL HAZARD

Strong oxidizing agent. Contact with water slowly liberates irritating and hazardous chlorine containing gases. Decomposes at temperatures above 437°F (225°) with liberation of harmful gases. When ignited, will burn with the evolution of chlorine and equally toxic gases.

IN CASE OF FIFE OR SMOKE: Call the fire department. Do no attempt to extinguish the fire without a self-contained breathing adjustus (SCRA). Do no let the fire burn. Flood with copious amounts of water. Do not use ABC or other dry chemical extinguishers since there is the potential for a violent reaction.

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

FOR INDUSTRIAL USE ONLY

This product is intended for repackaging and formulating as a microbiocide/microbiostat disinfectant, sanitizer, bactericide, fungicide, or algaecide into end-use products for the following general use sites: aquatic non-food industrial. aquatic non-food residential, indoor food, indoor non-food, and indoor residential. Re-packers or formulators using this product are responsible for obtaining EPA registration of their products.

This product may be used by manufacturers of non-pesticidal products provided no pesticidal claim is made.

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal **STORAGE**: Keep material dry and in a dry area. Store in original container where temperatures do not exceed 125°F (52°C) for 24 hours. Retie polyethylene liner after each use and keep container tightly closed.

PESTICIDE DISPOSAL: Pesticide wastes are toxic. Improper disposal of excess pesticide, spray mixture, or rinsate is a violation of Federal Law.
