

- c. Delete the statement "special purpose coatings" wherever it may appear on the label.
- d. Add the phrase "In Industrial Use settings Only" at the beginning of the second sentence that begin with "Add Intace Fungicide B-350 to the exterior paint and coatings....".

The basic Confidential Statement of Formula dated August 9, 2004 is in compliance with PR Notice 92-1, agrees with the label and is acceptable.

The Product Chemistry Data was found to be acceptable with the exception of the joint study for the storage stability and corrosion characteristics. The study must be submitted to the Agency 15 months after the date of this registration. Results are expected upon completion.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA sec. 6(e). Your release for shipment of the product constitutes acceptance of these conditions.

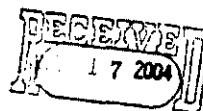

Intace Fungicide B-350 is intended for use as an industrial fungicide for the control of fungal growth on exterior paint and coatings, adhesives, caulks and sealants, exterior plaster coatings, architectural and special purpose coatings for wallboard, insulation covering and other building construction applications.

Intace Fungicide B-350 is an industrial microbiocide that will suppress fungi growing on paints and coatings, adhesives, caulks and sealants, exterior plaster coatings architectural and special purpose coatings for wallboard, insulation covering and other building construction applications which are exposed to conditions favoring microbial growth.

NOT FOR USE IN COATINGS OR ADHESIVES THAT WILL COME IN CONTACT WITH FOOD.

It is chemically inert and will not react with the other ingredients in the solution. Add Intace Fungicide B-350 to the exterior paint and coatings, adhesives, caulks and sealants, exterior plaster coatings, and architectural and special purpose coatings at levels of 5 gallons/100 gallons to 20 gallons /100 gallons depending on the substance to be protected, the fungal hazard, and the duration of the product desired.
