Do not apply this product in a way that will contact workers or other persons, either directly or through drift. Only protected handlers may be in the area during application. AGRICULTURAL USE REQUIREMENTS

Use this product only in accordance with its labeling and with the Worker Protection Standard, 40 CFR part 170.
