- 6. Christmas tree farms;
- 7. Managed transportation and utility rights-or-way, including rail and equipment yards, and public utility facilities (substations, tank farms, pumping stations, parking/storage areas, ungrazed fencerows).

This product is a technical active ingredient intended to be used only in the manufacture of registered non-crop end-use products. Each formulator is responsible for obtaining the EPA registration for their formula(s).
