This product is conditionally registered in accordance with Section 3(c)(7) of the Federal Insecticide, fungicide, and Rodenticide Act, as amended, provided you submit an acceptable accelerated 14 day study and a storage stability study within 18 months of the date of this registration.

This product is conditionally registered in accordance with Section 3(c)(7) of the Federal Insecticide, fungicide, and Rodenticide Act, as amended, provided you make the following label changes:

1. Under "Signal Word";

Change "CAUTION" to "WARNING."

2. Under "First Aid";

a. The sequence of the first aid treatment type is based on the toxicity or severity of each route of entry. Since the effects of primary skin and primary eye irritation are more severe than the other two, the eye and skin treatments must appear as the first two entries.

b. Add the following statements on "If Inhaled";

- Move person to fresh air.
- If person is not breathing, call 911 or an ambulance, then give respiration, preferably by mouth-to-mouth, if possible.
- Call a poison control center or doctor for treatment advice.

c. Under "If swallowed";

Add "Do not give anything by mouth to an unconscious person."

d. Add the following statement at the end of the "First Aid" Box:

You may also contact (toll-free number) for emergency medical treatment.

3. Under "Precautionary Statements";
 - a. Replace "Harmful if swallowed" with the following:

"This product causes skin irritation, substantial but temporary eye irritation. Harmful if swallowed or inhaled. Wear protective eye wear (goggles or face shield)."
 - b. It is suggested that you add the following statements at the end of this section:

"Users should wash thoroughly and change into clean clothing. Dirty clothing should be washed separately from other laundry."

4. Under "Environmental Hazards";

Add "This product is toxic to shrimp."

5. A recent acute toxicological study on the RiceCo Duet 60 DF (EPA Reg. No. 74530-23) indicate that the product is classified as category II for primary eye and skin irritation. This product contains 60% Propanil. Based on this study RiceCo has required that applicators and handlers must wear coverall, chemical resistant gloves, protective eyewear and footwear (copy enclosed).

It is recommended that you add a paragraph on personal protective equipment (PPE), and require persons handling this product to wear the following PPE:

- Coveralls.
- Chemical resistant gloves made of waterproof materials, such as butyl rubber 14 mils, natural rubber \geq 14 mils, neoprene rubber \geq 14 mils, or nitrile rubber \geq 14 mils.
- Chemical resistant footwear plus socks.
- Protective eyewear, such as chemical goggles or faceshield.
- Chemical resistant headgear for overhead exposure.

6. Under "Storage and Disposal";

Change "Storage" to "Pesticide Storage."

7. Add on the front panel, "EPA Reg. No. 74530-10" and "EPA Est. No. 74530-XX-XX."

Submit one copy of your final printed labeling before you release the product for shipment.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA section 6(e). Your release for shipment of the product constitutes acceptance of these conditions.

PRECAUTIONARY STATEMENTS

CAUTION

STORAGE AND DISPOSAL

STORAGE: Do not contaminate water, food, or feed by storage or disposal. Open dumping is prohibited. Do not store this product near fertilizers, seeds, insecticides, or fungicides. Do not store near heat or open flame. Containers should not be stacked more than four (4) high. Reclose all partially used containers by tying bag top shut. Damaged or leaking containers which contain product that cannot be used immediately should be transferred to suitable sound containers and properly marked. Sweep up any spill and dispose of as indicated under 'Pesticide Disposal'.

For safety and prevention of unauthorized use, all pesticides should be stored in locked facilities.

Opened, partially used pesticides should be stored in original containers when possible. When transfer to another container is necessary because of leakage or damage, carefully mark and identify contents of the new container.
