**GENERAL PRECAUTIONS AND RESTRICTIONS** 

Do not apply this product in a way that will contact workers or other persons. PULP AND PAPER SYSTEMS

This product aids in the control of objectionable bacteria and fungi in pulp, paper mill and the additive system, and for the preservation of pulp, pigment slurnes, alum, emuisions, agnesives, defoamers, polymers and paper product). Additions can be made on a continuous or intermittent basis, depending upon the severity of the comamination. BADLY FOULED SYSTEMS must be cleaned before treatment is begun.

The product should be added directly to the pulp and paper mill system. Apply at a point in the system where the product will be uniformly mixed.

INTERMITTENT OR SLUG METHOD - INITIAL DOSE: When the system is noticeably fouled, add this product at the rate of 0.5 to 50 pound or ton of pulp or paper produced. Additions to additive system should be made directly of the rate of 0.5 to 4.0 pound (60 to 480 ppm) per 1000 gallons. Repeat until builtrol is achieved. SUBSEQUENT DOSE: When microbial control is evident, add this product at the rate of it. 1 to 0.5 pound per ton of pulp and paper produced. Treat the system as needed to maintain control. Architions to the additive system may be reduced to 0.25 to 2.0 pound (30 to 240 ppm) per 1000 gallons.

CONTINUOUS FEED METHOD - INITIAL DOSE: When the system is noticeably fouled, add this product at the rate of 0.1 to 1.0 pound per ton of pulp or paper produced. Additions to the additive system should be made directly at the rate of 0.5 to 4.0 pound (60 to 480 ppm) per 1000 gallons. Continue until control is achieved. SUBSEQUENT

DOSE: Maintain the following level by continuous feed of this product at the rate of 0.1 to 0.3 pound per ton of pulp and paper produced. Additions to the additive system should be at the rate of 0.1 to 1.5 pound (12 to 180 ppm) per 1000 gallons.

MOLD INHIBITION IN PAPER AND PAPERBOARD; This product is used to inhibit fungal growth which causes discoloration, odor and degradation in paper and paperboard grades for construction, industrial and non-food uses. This product may be applied to the hydropulper or dump chest at the rate of 5.0 to 20.0 pound per ton of dry fiber produced. Application can also be made at the size press or water box. In this case, the application is made at the rate of 200 to 1000 ppm of this product in the sizing solution applied to the paper sheet, FOR PRESERVATION

This product should be added directly to the material to be preserved prior to manufacturing into the finished product, i.e., pulp, broke, polymer, defoamers, alum, emulsions, adhesives, paper mill coatings, pigment sturries and paper products. The dosage rate will depend upon the material to be preserved and the storage time. The usual additions should be 200 to 300 ppm and under extreme conditions of spoilage the dosage rate should be increased to 250 to 800 ppm. The above recommendations are based on a maximum storage time of two weeks. For storage time greater than two weeks, the maximum concentration should be increased to 1000 ppm.

### STORAGE AND DISPOSAL

PESTICIDE STORAGE: Keep container tightly closed. Protect from freezing. Store in a dry place. Do not store at elevated temperatures.
