This product aids in the control of objectionable bacteria and fungi in pulp, paper mill and the additive system, and for the preservation of pulp, pigment sturries, alum, emulsions, adhesives, defoamers and polymers. Additions can be made on a continuous or intermittent basis, depending upon the severity of the contamination, BADLY FOULED SYSTEMS must be cleaned before treatment is begun.

FOR SLIME CONTROL

The product should be added directly to the pulp and paper mill system. Apply at a point in the system where the product will be uniformly mixed. INTERMITTENT OR SLUG METHOD - INITIAL DOSE: When the system is noticeably fouled, add this product at the rate of 0.75 to 7.5 pound per ton (dry basis) of pulp or paper produced. Additions to additive system should be made directly at the rate of 0.50 to 5.4 pound per 1000 gallons (60 to 650 ppm) Repeat until control is achieved. SUBSEQUENT DOSE: When microbial control is evident, add this product at the rate of 0.6 to 5.75 pound per ton (dry basis) of pulp produced. Treat the system as needed to maintain control. Additions to the additive system may be reduced to 0.33 to 5.4 pound per 1000 gallons (40 to 650 ppm).

CONTINUOUS FEED METHOD - INITIAL DOSE: When the system is noticeably fouled, add this product at the rate of 0.75 to 2.0 pound per ton of pulp or paper produced. Additions to the additive system should be made directly at the rate of 0.50 to 5.4 pound per 1000 gallons (60 to 650 ppm). Repeat until control is achieved. SUBSEQUENT DOSE: Maintain the following level by continuous feed of this product at the rate of 0.6 to 1.75 pound per ton of pulp or paper produced. Treat the system as needed to maintain control. Additions to the additive system may be reduced to 0.33 to 5.4 pound per 1000 gallons (40 to 650 ppm).

FOR PRESERVATION

This product should be added directly to the material to be preserved prior to manufacturing into the finished product. The dosage rate will depend upon the material to be preserved and the storage time. Emulsions, add 0.08 to 1.29 pound of product to each 1000 pound of emulsion to provide 75 to 1300 ppm product. Polymer, starch, defoamers, alum, adhesives, paper mill coatings and ploment slurries, add 0.08 to 0.65 pound of product to each 1000 pound of fluid to provide 75 to 650 ppm product. Pulp or broke, add 6 to 26 pound of product to each 1000 pound of fluid to provide 150 to 650 ppm product. The above recommendations are based on a maximum storage time of two weeks. Repeat dosing every 7 to 14 days for storage time longer than two weeks.

STORAGE AND DISPOSAL
