After 18 months, you may only distribute or sell this product if it bears this new revised labeling or subsequently approved labeling. "To distribute or sell" is defined under FIFRA section 2(gg) and its implementing regulation at 40 CFR 152.3.

#### DIRECTIONS FOR USE

It is a violation of federal law to use this product in a manner inconsistent with its labeling.

**Product Description**: Shelter Island is a solvent based, copper and tin free controlled wear rate antifouling which releases its biocide via a constant exposure of the film in all waters, salt, brackish and fresh water. The ablative copolymer system of Shelter Island combines a controlled wear rate with biocide release with an inherent smooth tough film. Shelter Island contains a high loading of patented SCX biocide and select zinc oxide to enhance the performance and environmental demands for use on commercial vessels of aluminum, steel and fiberglass.

**Surface Preparation:** Surface must always be clean, dry and properly prepared prior to painting. Failure to do so will lead to eventually blistering and/or peeling.

**General Application:** For use on vessels below the true waterline. Can be sprayed, rolled or in small areas, brushed.

Apply at least 2 coats for best performance, as the life of the paint is proportional to the number of coats applied.

Do not apply this product in a way that will contact adults, children or pets either directly or through drift.

**Spray Drift Management:** A variety of factors including weather conditions (e.g. wind direction, wind speed, temperature, relative humidity) and method of application can influence pesticide drift. The applicator must evaluate all factors and make appropriate adjustments when applying this product.

**Mixing and Thinning:** Shake or mix thoroughly and stir continuously while using. Thin only when necessary with Thinner 974 for roller applications and Thinner 975 for spray.. **Theoretical Coverage:** Depending on surface conditions, one gallon of bottom paint will usually cover over 400 square feet of surface when roll applied at 2.0-2.5 mils dry film thickness

**Clean Up:** Use Thinner 975 for cleaning equipment and paint brushes.

**Estimated Dry Times:** Bottom paints are designed for over coating after an overnight dry. Prior to launching, allow a minimum dry of overnight. If drying conditions are poor or if paint was applied too thickly, longer periods of drying will be required. . Fresh coats of paint must be thoroughly dry before over coating.

**Yearly Repainting:** Scrub bottom clean at haul-out. Repaint only if old paint is sound and intact; if not, remove it . If old paint is rough, grind/sand it until smooth. Spot coat any bare areas with either Barriershield Primer or on metals Bottom Protect Epoxy Primer. Allow to touch dry to over coat. Apply 2 coats of Dhelter Island .

**On Bare Steel:** Sandblast surface to a near white metal; remove blast residue with a broom and air hose. Apply 3-4 coats of Bottom Protect Epoxy Primer. Allow to touch dry and apply 2 coats of Shelter Island

**On Bare Aluminum** - Sandblast as above using a non-metallic abrasive. Remove blasting dust and apply 1 coat of Blue Water Strontium Chromate Epoxy Primer. Allow to dry in accordance with specification and apply 3-4 coats of Bottom Protect Epoxy Primer. Allow to touch dry and apply two coats of Shelter Island .

**On Bare Wood:** If seams are not flush, fill them with seam compound. Dry several days until skin forms. Do not sand. Apply first coat of Shelter Island (reduced 10% with Thinner 974) then follow with 2 additional unreduced coats of Shelter Island .

On Bare Fiberglass: Dewax by washing with Dewaxer 973, remove dissolved wax at

once with clean paper towels or rags; repeat; sand hard to a dull finish with 80-100 grit sandpaper. Apply 3-5 coats of Bottom Protect Epoxy Primer. Allow to touch dry as above and apply 2 coats of Shelter island
