FIRST AID

Directions For Use

It is a violation of Federal law to use this product in a manner inconsistent with its labeling. For application on trees, shrubs, and flowers; and at the edge of gardens and inanimate objects. For use against dogs and cats to reduce the frequency of defecation, urination or walking in specific areas. For use outdoors or indoors as directed.

Use Restrictions

Avoid contamination of food and foodstuffs or drinking water. Do not use near fire or flame.

OUTDOOR PRE-APPLICATION DIRECTIONS

At the proposed sites, (plants, or shrubs), for the use of TWIST-ONS remove any nearby pet droppings and wash away odors of urine or droppings near the plants by using a strong soap powder and a garden hose.

OUTDOOR APPLICATION DIRECTIONS

Attach TWIST-ONS to lower branches of EVERGREENS, SHRUBS, PLANTS, etc. about 12" to 15" above ground, 2 to 3 feet apart. TWIST-ONS may also be attached to lids of garbage cans, outdoor furniture etc. For use on small plants or other plants that may be poisonous to pets if ingested (such as Amaryllis, Asparagus Fern, Baneberry, Daffodil, Iris, Tulips, and Peony). Ask your dealer for the list and pictures of plants that may be poisonous to pets, if ingested by pets. Make sure to use TWIST-ONS in conjunction with training, and voice commands.

INDOOR APPLICATIONS

Attach TWIST-ONS to lower branches of the CHRISTMAS TREE to ward off pets from their mischievous chewing, biting and clawing at the ornament. To protect pets TWIST-ONS may also be attached to indoor plants such as Deffenbachia, Rubber Plants, Calla Lilies, and Tulips which may be poisonous to pets, if pets ingest the leaves, stems, or flowers of these plants.

STORAGE AND DISPOSAL

Storage: Store only in original container, in a dry, cool place inaccessible to children and pets. **Disposal**: Do not reuse empty containers. Discard in trash.
