TO CLEAN: 1. Shake, apply product & wipe away.

TO DISINFECT: 1. Shake well and wet the surface with the spray (test for surface compatibility on inconspicuous area first). 2. Leave for 10 minutes; allow to air-dry, no rinsing or wiping is required, except on direct oral, skin or food contact surfaces which require a potable water rinse after treatment (e.g. baby toys, prostheses liners & food trays).

Storage / Disposal: Store airtight at room temperature. Recycle empty container.
