- d. The final sublabel you submitted is not acceptable since you have not included complete directions for use for Indoor application and have added a number of unacceptable direct or implied safety and efficacy claims as follows:
- 1. Delete "Class IV Chemical, No Organo Phosphates, Approved for Use around children and pets and .25% Strong Solution".
- 2. Delete the entire paragraph under the heading "About This Product".
- 3. Complete instructions under household pests must be given as indicated on the draft labeling. You cannot say "for a complete list go to xxx etc.".
- 4. The complete ingredient statement must be listed in addition to all precautions and limitations appearing on the draft label.

If you want to use a sublabel off the master label such as for homeowner pests or for livestock pests or for ornamental pests you must use the same directions as they appear on the master label. You cannot modify the language or make reference to a website for complete list of pests and instructions.

If you intend to utilize a sublabel submit a copy of the labeling for our review.

Wash thoroughly after handling and before smoking or eating. Avoid contamination of feed and foodstuffs. Remove pets and birds and cover fish aquaria before surface applications. Do not use on humans. Do not allow children or nets to

INDOOR APPLICATION

"ousehold Pests: For spot application only. Do not use as a space spray indoors.

Ready to use. Affix trigger, pump or other type of sprayer to container for application. Do not transfer to another container.

SURFACE SPRAYING: FOR 60-DAY (TWO MONTHS) CONTROL OF: COCKROACHES, WATERBUGS, PALMETTO BUGS, SCORPIONS, MILLIPEDES, SPIDERS, CRICKETS, CLOVER MITES, CHEESE MITES, GRANARY WEEVILS, RICE WEEVILS, CONFUSED FLOUR BEETLES, RUST RED FLOUR BEETLES, DRUGSTORE BEETLES, MEAL WORMS, GRAIN MITES AND CADELLES: Direct the spray into hiding places, cracks and crevices and behind shelves and drawers. For Silverfish, spray bookcases. For Ants, spray trails, nests and points of entry.

TO CONTROL CARPET BEETLES: Spray edges of carpeting and under carpeting and rugs. Make localized application to floor and baseboards. Spray directly into cracks, crevices and infested areas of shelving. Repeat treatment as needed.

TO CONTROL BEDBUGS: Spray mattresses lightly, particularly around tufts and seams. Take beds apart and spray in all joints. Treat baseboards, moldings and floors. Repeat treatment as needed.

I O CONTROL FLEAS (ADULTS AND LARVAE) AND TICKS (ADULT AND LARVAE): Thoroughly spray infested areas, pet beds, resting quarters, nearby cracks and crevices, along and behind baseboards, moldings, window and door frames, and entire areas of floor and floor covering. Fresh bedding should be placed in animal quarters following treatment. Repeat treatment as needed. Allow drying thoroughly before allowing pets to contact treated areas.

TO CONTROL CLOTHESMOTHS: Remove any infested articles from storage, brush thoroughly and air for several hours in sunlight, if possible. Apply spray liberally to empty chests, closets, bureaus and other storages directing the spray into cracks, joints and crevices. After airing, infested articles may be treated lightly, keeping nozzle at least three feet from fabric to avoid staining.

TO KILL LICE AND LOUSE EGGS: Spray in an inconspicuous area to test for possible staining or discoloration. Inspect again after drying, and then proceed to spray entire area to be treated. Spray from a distance of 8 to 10 inches. Treat only those garments and parts of bedding, including mattresses and furniture that cannot be either laundered or drycleaned. Allow all treated particles to dry thoroughly before use.

Livestock Pests

Ready to use. Affix trigger, pump or other type of sprayer to container for application. Do not transfer to another container.

On Livestock: To protect cattle (beef and dairy), goats, sheep, hogs and horses from Horn Flies, Face Flies, Houseflies, Mosquitoes and Gnats. Apply a light mist sufficient to wet the surface of the hair. For Face Flies, spray face and head, but do not spray into eyes.

To Control Stable Flies, Horse Flies and Deer Flies: Apply at a rate of 2 ounces per adult animal, sufficient to wet the hair thoroughly. Repeat treatment daily or at intervals necessary to give continued protection.

To Control Blood-Sucking Lice: Apply to the infested areas of the animal, using a stiff brush to get the spray to the base of the hair. Repeat every 3 weeks if required.

To Control Poultry Lice: Spray roosts, walls and nests or cages thoroughly. Spraying over the birds with a fine mist should follow this.

To Control Bedbugs and Mites in Poultry Houses: Spray crevices of roost poles, cracks in walls and cracks in nests where the Bedbugs and Mites hide. Allow all treated articles to dry thoroughly before use.

On Dogs, to Control Fleas, Ticks and Lice:

Ready to use. Affix trigger, pump or other type of sprayer to container for application. Do not transfer to another container. Do not use on dogs under 12 weeks old. Consult a veterinarian before using this product on redicated, debilitated, aged, pregnant or nursing animals.

Sensitivities may occur after using ANY pesticide product for pets. If signs of sensitivity occur bathe your pet with mild soap and rinse with large amounts of water. If signs continue, consult a veterinarian immediately

Start spraying at the tail, moving the dispenser rapidly and making sure that the animal's entire body is covered, including the legs and underbody. While spraying, fluff the hair so that the spray will penetrate to the skin. Make sure spray wets thoroughly, but do not saturate animal. Do not spray into eyes or face. Avoid contact with genitalia. Repeat application every two weeks, if necessary. DO NOT USE ON FELINES. (CATS)

OUTDOOR APPLICATION

To help control ticks in outdoor activity areas: Ready to use. Affix trigger, pump or other type of sprayer to container for application. Do not transfer to another container.

Treat a band of vegetation and leaf litter 6 – 10 feet wide and adjacent to activity areas, especially where dense vegetation occurs.

Jets on the Outdoor Surface of Buildings: To temporarily control houseflies, mosquitoes, cluster flies, gnats and flying moths. For outdoor use only as aid in reducing annoyance from these insects.

Dilute before using. Use clean sprayer. Carefully measure and mix 1 fluid ounce of ANT AND ROACH PROTECTION and 12 fluid ounces of water. Using dilute mixture, spray pests on outside surfaces of screens, doors, window frames or wherever these insects may enter the room. Also treat surfaces around light fixtures on porches, in garages and other places where these insects alight to congregate. Repeat as necessary. Flush sprayer with clean water after each use.

ORNAMENTAL FLOWER GARDENS:

Ready to use. Affix trigger, pump or other type of sprayer to container for application. Do not transfer to another container.

For use on roses, dahlias, asters and other ornamentals to kill Japanese Beetles hit by sprey as well as Whiteflies, Aphids, Exposed Thrips, Spiders, Red Mites and Leafminers. May be used on plants as a multi-purpose spray in small gardens and for spot treatments of incipient insect infestations to prevent spreading to large garden areas.

May also be used on other plants such as African violets, asters, azaleas, begonias, carnellias, carnations, chrysanthemums, dahlias, delphiniums, dogwoods, English ivy euronymus, fuschia, geraniums, crassula, grape vines, Kentia palms, laurels, marigolds, rhododendrons, roses, rubber plants, snapdragons, stocks wandering jewa and zinnias.

Effective when used as directed against Whiteflies, Aphids, Spider and Red Mites, exposed Thrips, Lace Bugs, Japanese Beetles, Pavement Ants, Clover Mites and Armyworms.

When spraying plants, do not operate closer than 18 inches. Use sweeping motion. Be cautious about wetting tender foliage, young plants and new growth. Do not spray plants when temperatures exceed 90°F. Contact insects directly whenever possible. Repeat treatment as infestations occur.

Ornamental Trees Around the Home: Dilute before using. Use clean sprayer. Carefully measure and mix 1 fluid ounce of ANT AND ROACH PROTECTION and 12 fluid ounces of water. Using dilute mixture, use sufficient spray to obtain full coverage of all foliage. Avoid heavy wetting. Use to control: Pine Moths, Pine Needle Miners, Pine Beetles and Needle Scales on pine: Budworms on conifers; Oakworms on oak; Fall webworms on cherry, elm and honeysuckle; Aphids on tulip poplar, Citrus black flies on non-bearing citrus; Tussock Moths on Douglas and grand firs; Leafminers on birch; Elm Leaf Beetles and Elm Spanworms on elms. Flush sprayer with clean water after each use.

For Home Vegetable Gardens: Dilute before using. Use clean sprayer. Carefully measure and mix 1 fluid ounce of ANT AND ROACH PROTECTION and 12 fluid ounces of water. Spray upper and lower leaf surfaces as directed. Use sufficient spray to obtain full coverage of all foliage, but do not spray to the point of runoff. Apply no more than 13 ounces of dilute mixture over 100 linear feet of row (13 ounces of diluted mixture per 100 square feet). Flush sprayer with clean water after each use.

Use sufficient spray to obtain full coverage of all foliage but do not spray to the point of run off. Make sure to spray the undersides of leaves and into dense foliage. Flush sprayer with clean water after each use.
