The Agency, in accordance with the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA), as amended, has completed reviewing all the information submitted with your application to support the Registration Review of the above referenced product in connection with the Sodium Metabisulfite Interim Decision, and has concluded that your submission is acceptable. The label referred to above, submitted in connection with registration under FIFRA, as amended, is acceptable.

Should you wish to add/retain a reference to the company's website on your label, then please be aware that the website becomes labeling under the Federal Insecticide Fungicide and Rodenticide Act and is subject to review by the Agency. If the website is false or misleading, the product would be misbranded and unlawful to sell or distribute under FIFRA section 12(a)(1)(E). 40 CFR 156.10(a)(5) list examples of statements EPA may consider false or misleading. 

To assure freshness by the fungicidal control of *Botritis cinerea* on table grapes.

- 1. Single Slow Release pad must be used in conjunction with initial sulfur dioxide fumigation. If sulfur dioxide fumigation is not possible or desirable, use Dual Release pad. If Dual Release pad is used, it is recommended to apply tissue or absorb sheet between grapes and pad.
- 2. Do not use defective pad or torn pad.
- 3. Use a polyethylene liner in an appropriate shipping container.
- 4. If desired, cover bottom of the polyethylene liner with cushion / humidity absorb material or other suitable packing material.
- 5. Place grape bunches inside the liner according to packing protocols.
- 6. Select the appropriate pad depending on the weight capacity and the size of the box. Do not place more than one .035 ounce (1 gram) of Active Ingredient per each 2.2 lbs. (1kg) of table grapes.
- 7. Fold the polyethylene liner over the grapes and close the box.
- 8. Place the boxes of packed grapes in refrigerated storage at $32-35^{\circ}$ F (0-2° C).
- 9. Remove pad from box before display of grapes for sale or after removal of container from retail store refrigeration facilities.
- 10. If the pad is torn, remove pad and damaged grapes. Do not reuse the pad.
