1. Delete the marketing claims:

"Odorless" from the bullets "EPA Registered" "Has no unpleasant smell or feel"

The term odorless is a subjective term depending on who you ask and also an implied safety claim. Likewise the phrase "No unpleasant smell or feel".

The only allowed reference to "registration" is the complete EPA Registration No. Other references such as "EPA registered" implies endorsement of the product by the Agency and not allowed. .
