Dear Ms. Mitchell,

We recently registered our label for Ultima Platinum Plus and was approved on 7/2/2008. Since then as I was reviewing the approved label to make sure the market label had all the corrections the were specified in your approval letter I noticed that a sentence mistakenly was omitted. In my opinion the sentence is an advisory statement that would help the end user use the product correctly. That sentence will be found in the "FOR MAINTENANCE APPLICATION AND WINTERIZING" section. It is the last sentence in the paragraph. The omitted sentence is "Platinum Plus levels should be tested once a month and maintained at a level of 30 – 50 ppm." It is added on the master label attached and the final printed labels with the revisions made as required in your letter. I have also added 3 marketing claims to replace those that were not allowed.

I hope you will agree that the sentence that was missing is an important piece of information for the user of this product and will allow this notification.


