 - d. Add a reentry statement to read "Do not allow persons or pets to enter into treated areas until sprays have dried."

- e. Relocate the misuse statement reading "It is a violation of federal law to use this product in a manner inconsistent with its labeling" so that it appears directly beneath the "Directions for Use" heading.
- f. Revise the First Aid Statement so that it is in compliance with PR Notice 2001-1. Specifically, the existing eye and dermal statements should read as follows:

FIRST AID	
If in eyes:	 Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing. Call a poison control center or doctor for treatment advice.
If on skin or clothing:	 Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control center or doctor for treatment advice.

DIRECTIONS FOR USE

Apply undiluted. Hold applicator approximately 12 inches away from soil or other surface and spray lightly and uniformly until surface appears wet. Do not drench the soil or other surfaces.

This product performs best if applied to dry surfaces, but can also be applied to damp soil. It is not necessary to dampen the soil before application.

This product may be applied:

- to bare soil or mulch;
- on and around ornamental plants, shrubs and ground covers;
- on pots; planters; garden furniture; statuary; fences; foundations; retaining walls; patios; walkways; patio furniture; decks
- on ornamental trees in a band approximately 12" wide around the whole trunk;
- on greenhouse floors, walls and benches;
- to damp, dark areas where snails and slugs shelter and breed.

Do not apply to ornamental moss. Some other plant species, such as orchids, are sensitive to copper and may be injured if it is applied to the foliage. To determine sensitivity, spray a few test leaves. Examine the test leaves for burn or spotting after 24 hours. Protect sensitive plants by applying this product only to the soil or mulch around the plants.

Avoid applying during rainfall. Allow the surface to dry before irrigation.

This product performs on porous and non-porous hard surfaces up to 12 weeks. Reapplication on soil may be necessary after 10-14 days. Reapply as needed.
