Dear Ms. Shoemaker:

The following amendments, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), as amended, are acceptable with the conditions listed below:

- Addition of optional labeling claims
- Revision to precautionary statements on front label
- Repetition of claims against *Staphylococcus aureus*, *Salmonella choleraesuis*, and *Pseudomonas aeruginosa*

Conditions:

- On page two (2) of the product label, you must remove the following words and phrases from the proposed optional marketing statements: "ultra-clean" and "safely". These claims are considered false and misleading.
- On page three (3) of the product label, you must revise the Precautionary Statements to read as follows: "CAUTION: Moderately irritating to eyes, skin, and mucous membrane. Avoid contact with eyes, skin or clothing. Harmful if swallowed or inhaled. Avoid breathing vapor. Remove and wash contaminated clothing before reuse. Wash thoroughly with soap and water after handling and before eating, drinking, chewing gum, or using tobacco. Do not mix with products that contain ammonia or dangerous fumes may result."
- On page three (3) of the product label, you must revise the First Aid Statement so that the last three routes of exposure read as follows:

"IF ON SKIN: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control center or doctor for treatment advice.

IF SWALLOWED: Call a poison control center or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to by a poison control center or doctor. Do not give anything to an unconscious person.

IF INHALED: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably mouth-to-mouth if possible. Call a poison control center or doctor for further treatment advice."

A stamped copy of the labeling accepted with conditions is enclosed. Submit one (1) copy of your final printed label before distributing or selling the product bearing the revised labeling.
