b. The Agency does not stamp labels with Alternate/Additional Brand name labels. The requested Alternate Brand names are acceptable, but have been removed from the attached label.

c. On page 2 of the label under directions for use add "Open in well ventilated area" to "Open a window or turn on a fan..." statement.

d. On pages 3 and 6 of this label all references to **porous surfaces** and **disinfectant** as it relates to Mold and Mildew have been removed.

e. On page 3 add the phrase "Remove gross filth and clean prior to disinfecting" under use directions for the claims "To Kill Mold & Mildew on Hard, Nonporous Surfaces" and "To Disinfect Toilet Bowls". Separate Toilet Bowl Cleaning and Toilet Bowl Disinfectant directions for use.

f. The label must be updated for Container Disposal to add "Cleaning the container before final disposal is the responsibility of the person disposing of the container. Cleaning before refilling is the responsibility of the refiller."

g. On pages 5, 6 and 7 of this label all references to **99.9% or 99.999%** and **disinfectant** as it relates to Mold and Mildew have been removed. In cases where the statement supports the germs or bacteria claims "Mold and Mildew" have been removed from the label. The quantitative claims, **99.999%** are unacceptable. The 5 log₁₀ reductions are limited to food contact sanitization claims.

h. On pages 6 and 9 the following allergens have been removed: Cat allergens, cockroach allergens, cockroach particles, dog allergens, dust mite particles, dust mite allergens, hair, pet allergens, pet dander, pet hair and pollen allergens. The Agency does not require data for non-living allergens to be submitted to support the claims. These allergens are to broad or could be considered as living allergens.

- i. On pages 7, 8 and 9 the following unsubstantiated marketing claims have been removed:
- Disinfects with the power of bleach (Heightened Efficacy)
 - more than – from the statement "Kills more than (99.9%)(99.999%)..." (Misleading)
 - at its source – from the statement "Penetrates to (kill)(eliminate) and destroy tough mold, mildew and bacteria at its source."
 - Use regularly for maximum home hygiene
 - (Thick) Gel (formula) Reduces bleach fumes
 - Foaming – This is a gel product.
 - See it and believe it
 - Prevents the growth of mold and mildew
 - Prevents mold and mildew

j. On pages 7 and 8, it is stipulated that organisms listed on the label should be inserted after the claim, or surfaces or use sites or soils. You must provide tables to correlate to the organisms, surfaces and use sites and soils.

k. Revise the Precautionary statement to read: "Corrosive. Causes skin burns. Causes moderate eye irritation. Do not get on skin, in eyes or on clothing. Wear protective clothing and gloves. Wash thoroughly with soap and water after handling and before eating, drinking, chewing gum, using tobacco or using restroom. Remove and wash contaminated clothing before reuse."

Based on the data submitted this product is toxicity category I for primary skin irritation which requires Child-Resistant Packaging (CRP) data/information. Please submit data/information for Agency review and acceptance.

The accepted alternate brand names are as follows: COMET Mold and Mildew Stain Remover; COMET Mildew Stain Remover; COMET Mildew Remover; COMET Mold and Mildew Stain Remover Spray Gel; COMET Mildew Stain Remover Spray Gel; and COMET Mildew Remover Spray Gel

3. Submit three (3) copies of your final printed labeling before distributing or selling the product bearing the revised labeling.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA sec. 6(e). Your release for shipment of the product constitutes acceptance of these conditions.

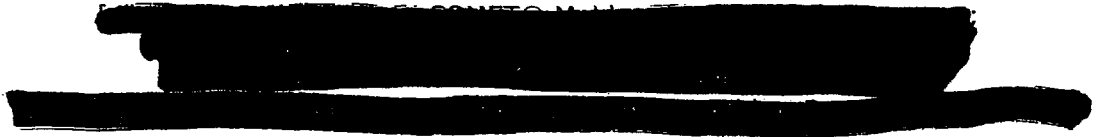
