b. Based on the composition of Tanalith T Permethrin-Based Lumber Preservative, some of the label statements recommended below for the product most likely overstate the true acute toxicity effects. However, in view of the absence of Agency required data support and aspiration hazard of mineral spirits, the product is being assigned Toxicity Category I for all acute effects as "worst case". Therefore, revise the Precautionary Statements and add PPE Statements as follows:

Precautionary Statements: Revise to include the following:

Corrosive, Causes Irreversible Eye Damage and Skin Burns, Fatal is Inhaled, May Cause Allergic Skin Reaction, May be Fatal if Swallowed and Absorbed through Skin.

Do not get in eyes, on skin, or on clothing. Do not breathe vapor or mist. Do not take internally. Use only with adequate ventilation. Remove contaminated clothing and wash clothing before reuse. Avoid contamination of food.

Personal Protective Equipment:

Use a full-face protective respirator fitted with an organic vapor cartridge, and wear protective eye wear (goggles, face shield, or safety glasses) while mixing or loading the product, and during any parts of the application process that may result in exposure. - f. Add footnote notations (e.g., asterisks or numbers) to the active ingredients "Permethrin" and "Other Ingredients", and add the following corresponding statements directly beneath the ingredient statement:

*Cis/trans ratio: max. 42% (+/-) cis and min. 58% (+/-) trans. **Contains Petroleum Distillate .

g. On the front panel, delete the word "approved" or add a footnote and asterisk to identify the type and criteria for approval.

- 3. Submit to the Agency:
 - Data on one year storage stability testing (830.6317), conducted concurrently with the corrosion characteristics study (830-6320) at 0, 3, 6, 9 and 12 months of warehouse storage.
 - A copy of the standards in AS/NZS 2843 (Referenced in Directions for Use).
- 4. Submit two (2) copies of the revised final printed label bearing the above stated revisions prior to releasing this product for sale.

If you do not comply with the above stated conditions, this registration will be subject to cancellation in accordance with FIFRA sec. 6(e). Your release of this product for shipment constitutes your acceptance of these conditions.

Wood preparation:

This product is intended for use to treat lumber that has been sawed and milled to dimension. Wood must be clean and dry before treatment and must have been kiln dried to permit adequate penetration of preservative during treatment.

Treatment:

Add undiluted Tanalith[®] T to a vat or other container of a size that is large enough to allow all lumber that is to be treated at one time to be completely covered by the Tanalith[®] T. Arrange lumber in such a manner that will allow liquid to contact all surfaces of lumber.

Lumber packs should be immersed in undiluted Tanalith[®] T for 30 to 60 seconds, followed by a 5 to 10 minute drain time.

Alternatively, lumber packs may be placed in an LOSP treatment plant vessel and flooded for 30 to 60 seconds. The solution should then be drained and a final vacuum of -85 kPa applied for 5 to 15 minutes.
