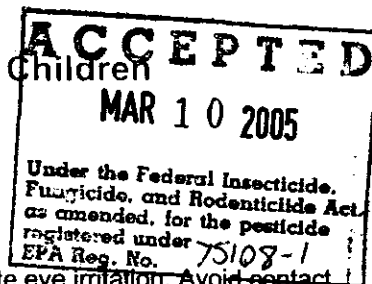

PRECAUTIONARY STATEMENTS

Hazards to Humans and Domestic Animals

Harmful if absorbed through skin. Causes moderate eye irritation. Avoid contact with skin, eyes, or clothing. Wear gloves. Wash thoroughly with soap and water after handling. Remove and wash contaminated clothing before reuse.

FIRST AID

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

Red Scale Down is a behavior-modifying biochemical (pheromone) that functions as a mating disruptor. Red Scale Down is intended to maintain low populations of California Red Scale (*Aonidiella aurantii*) in citrus.

APPLICATION:

The application rate for Red Scale Down in citrus is 100 dispensers per acre. Apply Red Scale Down at the beginning of each male flight of California Red Scale (CRS). Monitor the male flight with CRS pheromone traps and by visual inspection of the trees, leaves and fruit. For best results, use monitoring systems under the direction of a qualified pest control advisor. Use Red Scale Down to maintain low levels of pest population – time treatments accordingly. Re-apply Red Scale Down at the beginning of subsequent male flights based on the results from trap monitoring and field surveys. Do not exceed 400 dispensers per acre/year (160 mg active ingredients/acre/year).

METHOD OF APPLICATION:

Wear gloves when handling or applying dispensers. Provide adequate ventilation when handling dispensers. Do not handle dispensers in enclosed areas. Apply dispensers to plastic clips using one dispenser per clip. Make sure the dispenser is pulled well down into the center of clip. Using a pole, apply dispensers in the tree canopy, within two feet of tree tops.

To prevent cross contamination with other pheromone products that may be in use, either discard gloves after use, wash gloves very thoroughly before re-use, or dedicate their use to Red Scale Down activities only. Wash hands after handling Red Scale Down dispensers. Do not handle other types of insect lures before or after applying dispensers without thoroughly washing hands. Set monitoring traps before handling Red Scale Down dispensers. Monitor treatments carefully, and check for any secondary pests.

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal.

PESTICIDE STORAGE: Store container in a cool place until used. Immediately reseal storage bags after each use and return to cool storage. Do not use Red Scale Down if the bag is damaged, punctured or unsealed. Store only in refrigerators or freezers not used for food storage.

PESTICIDE DISPOSAL: Wastes resulting from the use of this product must be disposed of on site or at an approved waste disposal facility.

CONTAINER DISPOSAL: Dispose of empty storage bags in a sanitary landfill or by incineration, or, if allowed by State and local authorities, by burning. If burned, stay out of smoke.
