PESTICIDE STORAGE: Store container in a freezer until used. Immediately reseal container after each use and return to freezer. Do not use California Red Scale Technical Pheromone if the container is damaged, punctured or unsealed. Store only in locked freezers not used for food storage.

PESTICIDE DISPOSAL: Wastes resulting from use of this product must be disposed of at an approved waste disposal facility.

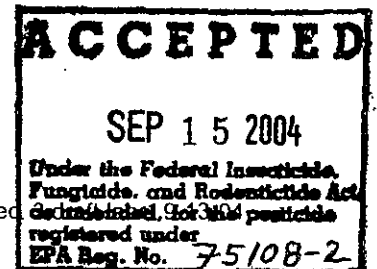
CONTAINER DISPOSAL: Triple rinse (or equivalent). Then dispose of in a sanitary landfill or by other approved State and local procedures.
