- e) Add "Wear chemical resistant gloves when applying tags" to the Directions for Use section.
- 3. We have completed a occupational exposure risk assessment (copy enclosed) and conclude that risk concerns for handlers exposed during application are negligible. However to confirm that dermal post application exposure is also negligible we are requesting that you submit as a condition of registration efficacy data to confirm that residues have dissipated by week 53. Please indicate when this data will be submitted.
- 4. Please submit two (2) copies of your final printed label for before your release the product for shipment. Please refer to the A-79 enclosure for a further description of final printed labeling. If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA section 6(e). Your release for shipment of the product bearing amended labeling constitutes acceptance of these conditions. A stamped copy of the label is enclosed for your records.

ENVIRONMENTAL HAZARDS

This pesticide is toxic to fish. Do not apply directly to water. Do not contaminate water by disposal of used tags. Use this product only as specified on this label.

DIRECTIONS FOR USE

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

Control of heavy infestations of Northern Fowl Mites may require treating the birds and/or facility by traditional methods (e.g., spraying, dusting, or dipping) before attaching SWIFTACK Miticide Tags to birds. Remove tags before processing birds.

Method of Attachment

Attach the insecticide tag to the bird with the patented SWIFTACK Applicator Tool as follows: (1) slide the tag onto the applicator needle; (2) insert the needle through the wing web directly below the arm bone; (3) squeeze the applicator two times sending two fasteners through the tag and the wing web, and (4) remove the needle. This will result in the attachment of the insecticide tag to the wing web with two fasteners for excellent retention.

Chicken Breeders: At time of bird placement attach one tag, using two fasteners to each wing web of the ROOSTERS ONLY. Each rooster should receive a total of two tags, one in each wing web. Do not apply insecticide tags to the hens, as they will receive treatment from contact with the roosters.

Caged Layers: At time of bird placement attach one tag, using two fasteners, to one wing web of every fifth bird in the same cage (1:5 ratio).

Turkey Breeders: At time of bird placement attach one tag, using two fasteners, to the wing web, directly under the arm bone, of each tom and/or hen turkey.

STORAGE AND DISPOSAL

PESTICIDE STORAGE: Do not contaminate water, food, or feed by storage or disposal. **PESTICIDE DISPOSAL:** Remove tags before processing birds. Securely wrap used tags in a plastic bag or several layers of newspaper and discard in trash for disposal in a sanitary landfill.

CONTAINER DISPOSAL: Dispose of empty container(s) in a sanitary landfill or by incineration, or, if allowed by State and Local authorities, by burning. If burned, stay out of smoke.
