On the basis of information furnished by the registrant, the above named pesticide is hereby registered/reregistered under the Federal Insecticide, Fungicide and Rodenticide Act.

In order to protect health and the environment, the Administrator, on his motion, may at any time suspend or cancel the registration of a pesticide in accordance with the Act. The acceptance of any name in connection with the registration of a product under this Act is not to be construed as giving the registrant a right to exclusive use of the name or to its use if it has been covered by others.

This product is conditionally registered in accordance with FIFRA sec. 3(c)(7)(A), provided that you:

- 1. Submit and/or cite all data required for registration/reregistration of your product under FIFRA sec. 3(c)(5) when the Agency requires all registrants of similar products to submit such data; and submit acceptable responses required for reregistration of your product under FIFRA section 4.
- 2. Make the following labeling changes:
  - Revise the EPA Registration Number to read "EPA Reg. No. 75257-1". a)
  - **b**) Under Precautionary statements separate the hazards to humans from the hazards to domestic animals. Revise the hazards to humans to read as follows:

<u>Hazards</u> to Humans: Harmful if absorbed through skin. Causes moderate eye irritation. Avoid contact with skin, eyes, or clothing. Prolonged or frequently repeated skin contact may cause allergic reactions in some individuals. Wash throughly with soap and water after handling and before eating, drinking, chewing gum, or using tobacco. Remove and wash contaminated clothing before reuse.

Hazards to Domestic Animals: Consult a veterinarian before using this product on debilitated.... consult a veterinarian immediately.

- c) Move all cat information to a box under Precautionary statements to help draw the consumer's attention to this information. The following precautionary statements should appear on the label: "May be toxic and potentially fatal if applied to or ingested by cats. Cats which actively groom or engage in close physical contact with treated dogs may be at risk of serious harmful effects". This last statement must be highlighted.
- d) In addition to the above referred box, an icon of a cat in a circle with a slash through it should be added to the label's front panel. Circle and slash should be red in color. The statement "Do not use on cats" and/or the icon must also appear on the small tubes.
- e) Since this product is placed in acute toxicity category IV for the oral, inhalation, and dermal irritation routes, only the "If on skin and clothing" and the "If in eyes" first aid statements are required. If you choose to keep the "If Swallowed" statements, they should be listed last.
- f) Under Environmental Hazards add: "and other aquatic organisms" to the end of the first sentence. Also, delete the last sentence.
- g) Revise the Pesticide and Container Disposal statements to read: "If empty: Do not reuse this container. Place in trash or offer for recycling if available. If partially filled: Call your local solid waste agency for disposal instructions. Never place unused product down any indoor or outdoor drain".
- h) Delete "Each tube provides 1 month protection" since this conflicts with your claims for 5/6 weeks.
- 3. Please submit two (2) copies of your final printed label before you release the product for shipment. If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA section 6(e). Your release for shipment of the product bearing amended labeling constitutes acceptance of these conditions. A stamped copy of the label is enclosed for your records.

## Ready to use, no dilution necessary.

- Hold tube in upright position pointing away from user's face and body. Break off tip or cut
  with scissors. Using the cc marks on the body of the applicator as a guide apply
  FREEDOM 45 FOR DOGS as follows by gently squeezing the applicator.
- Part dog's hair between the shoulder blades.
- Apply the recommended amount of solution to the skin on the dog's back between the shoulder blades. For large and extra-large dogs, application of the solution to the skin directly in front of the base of the dog's tail is also required. SEE RECOMMENDED DOSING GUIDELINES BELOW.

#### Package for dogs weighing 33 lbs or less

Apply 1.5 cc of FREEDOM 45 FOR DOGS to the skin of the dog's back between the shoulder blades.

## Package for dogs weighing 33 - 66 lbs

Apply 1.5 cc of FREEDOM 45 FOR DOGS to the skin of the dog's back between the shoulder blades and 1.5 cc to the skin directly in front of the base of the dog's tail.

#### Package for dogs weighing more than 66 lbs

Apply 3.0 cc of FREEDOM 45 FOR DOGS to the skin of the dog's back between the shoulder blades and 3.0 cc to the skin directly in front of the base of the dog's tail.

#### Multi package

For dogs weighing 33 lbs or less

Apply 1.5 cc of FREEDOM 45 FOR DOGS (1 tube) to the skin of the dog's back between the shoulder blades.

## For dogs weighing 33 - 66 lbs

Apply 1.5 cc of FREEDOM 45 FOR DOGS (1 tube) to the skin of the dog's back between the shoulder blades and 1.5 cc (a second tube) to the skin directly in front of the base of the dog's tail.

## For dogs weighing more than 66 lbs

Apply 3.0 cc of FREEDOM 45 FOR DOGS ( 2 tubes) to the skin of the dog's back between the shoulder blades and 3.0 cc (another 2 tubes) to the skin directly in front of the base of the dog's tail.
