**DO NOT USE ON CATS**

Ready to use, no dilution necessary.

- Hold tube in upright position pointing away from user's face and body. Break off tip or cut with scissors. Using the cc marks on the body of the applicator as a guide apply **FREEDOM 45 FOR DOGS** as follows by gently squeezing the applicator.
- Part dog's hair between the shoulder blades.
- Apply the recommended amount of solution to the skin on the dog's back between the shoulder blades. For large and extra-large dogs, application of the solution to the skin directly in front of the base of the dog's tail is also required. **SEE RECOMMENDED DOSING GUIDELINES BELOW.**

Package for dogs weighing 33 lbs or less

Apply 1.5 cc of **FREEDOM 45 FOR DOGS** to the skin of the dog's back between the shoulder blades.

Package for dogs weighing 33 - 66 lbs

Apply 1.5 cc of **FREEDOM 45 FOR DOGS** to the skin of the dog's back between the shoulder blades and 1.5 cc to the skin directly in front of the base of the dog's tail.

Package for dogs weighing more than 66 lbs

Apply 3.0 cc of **FREEDOM 45 FOR DOGS** to the skin of the dog's back between the shoulder blades and 3.0 cc to the skin directly in front of the base of the dog's tail.

Multi package

For dogs weighing 33 lbs or less

Apply 1.5 cc of **FREEDOM 45 FOR DOGS** ( 1 tube) to the skin of the dog's back between the shoulder blades.

For dogs weighing 33 - 66 lbs

Apply 1.5 cc of **FREEDOM 45 FOR DOGS** ( 1 tube) to the skin of the dog's back between the shoulder blades and 1.5 cc (a second tube) to the skin directly in front of the base of the dog's tail.

For dogs weighing more than 66 lbs

Apply 3.0 cc of **FREEDOM 45 FOR DOGS** ( 2 tubes) to the skin of the dog's back between the shoulder blades and 3.0 cc (another 2 tubes) to the skin directly in front of the base of the dog's tail.
