- 1. Add the statement. "Do not apply this product to fish-bearing waters" to the front panel of the proposed product label.
- 2. Amend the product label to contain the following restrictive use language:

"Manufacturing Use Product for formulation into end-use products with intended uses only in man-made aquatic systems (wastewater treatment facilities, waste settling ponds, dredge spoil sites, vegetation-choked phosphate pits, tires, log decks, tree holes, septic ditches, animal waste effluent lagoons, ornamental water hyacinth beds, storm water retention basins, retention and detention ponds, ornamental ponds and fountains, flooded crypts, transformer vaults, abandoned swimming pools and artificial water holding containers) and the following natural aquatic use sites: vineyards, fruit and nut orchards, berry fields and bogs*, pastures and rangelands, woodland pools and meadows."

* Qualify the use site bogs by specifically identifying peat bogs. If peat bogs are not the intended use site, bogs must be deleted, so as not to confuse with cranberry bogs, etc.
