Revise the label as follows:

1. Revise the statement the statement stating "These wipes may not be suitable for some modern surfaces" by stating the surfaces qualified for use on such as (stainless steel, chrome, glass, vinyl).
2. The "Precautionary Statements" section on the proposed label indicates that users should avoid contact with the skin. This product is a towelette, revise the statement to read "**wear chemical resistant gloves when using this product**".
3. Revise "hard tiled floors" to read "*glazed tiled floors*".
4. ATCC designation numbers are required in one of the following locations.
  - On the data matrix
  - On the master label (as optional text) with the listing of the organisms claimed
  - As the final page of the master label (as optional text)


