Addition of microorganisms and marketing claims

Conditions

Revise the label as follows:

- 1.) Revise the following phrase by deleting all brackets as follows: "...including the Pandemic 2009 H1N1 Influenza A virus."
- 2.) Revise the directions for use to be in agreement with PR Notice 2000-5 and to provide additional clarification by stating:


