The following amendment, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), as amended, is acceptable subject to the conditions listed below.

Correct name of Active Ingredient as per Agency request

#### Conditions

In future submissions to the Agency, list all packaging sizes on the Application for Pesticide such that the application is in agreement with the label for this product.

Make the following revisions to the label:

1. As per PR Notice 2001-1 add the following statement to the First Aid section of the label: "Have the product container or label with you when calling a poison control center or a doctor, or going for treatment."

2. Revise the Directions for Use, Approved Commercial and Industrial Application on page two by changing the second paragraph to read as follows: "*Prepare solution* by simply adding BST...and stirring. *Dilute BST Protectant Concentrate C15* by adding 1 part BST...to 1 part water or other solvent..." such that this label incorporates mandatory language as per PR Notice 2000-5.

Add the following clarification in each instance (3 times) that this language appears on your label: "Polyurethane and cellulose foam for household, industrial and institution sponges and mops" or simply "and cellulose" referring to the foam to be treated in the Approved Residential Use section.

4. Revise the bullet on page 11 as follows: "Effective on modern hard non-porous washable surfaces made of fiberglass, glazed porcelain ... "

5. Revise the Container Disposal statement to read exactly as follows such that the appropriate language is used for metal containers: "Triple rinse (or equivalent). Then offer for recycling or reconditioning, or puncture and dispose of in a sanitary landfill or by other procedures approved by state and local authorities."
