#### FIRST AID

#### HAZARDS TO HUMANS AND DOMESTIC ANIMALS

#### **DIRECTIONS FOR USE**

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

Do not apply this product in a way that will contact workers or other persons, either directly or through drift. Only protected handlers may be in the area during application.

Do not attempt to use without having the necessary safety equipment. Dilute this product in water to provide working solutions with concentrations ranging from 0.005 percent to 0.5 percent triazole active ingredients by weight (0.0005% to 0.05% imidacloprid). This product may be mixed with other EPA registered products that are labeled consistently with the intended end use of this product. Apply the working solution to wood products using equipment and methods that include, but are not limited to, dip, spray, vacuum, pressure, and coating processes. Application procedures must rigidly adhere to the current specifications of Arch Treatment Technologies, Inc., and/or the American Wood Protection Association.

Processes used to apply Wolman® AG formulations shall leave no visible surface deposits on the wood. Visible surface deposits means a surface residue or crystallization on the treated wood. Small isolated or infrequent spots of chemical on otherwise clean wood shall be allowed.

Treatment of wood products with [this product] {or} [brand] protects wood against termites and other wood destroying insects, Ascomycetes, white rot, brown rot and dry rot. Wood treated with this product cannot be used to construct bee hives.

#### STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage or disposal.

**STORAGE**: Store in a cool, dry place. Open dumping is prohibited.

Empty the rinsate into the application equipment or a mix tank or store rinsate for later use or disposal. Repeat this procedure two more times. Then offer for recycling or reconditioning. If not available, puncture and dispose in a sanitary landfill.

{For containers > 5 gallons} Triple rinse as follows: Fill container ½ full with water. Tip container on its side and roll it back and forth, ensuring at least one complete revolution for 30 seconds. Stand the container on its end and tip it back and forth several times. Turn the container over onto its other end and tip it back and forth several times. Empty the rinsate into application equipment or mix tank or store rinsate for later use or disposal. Repeat this procedure two more times. Then offer for recycling or reconditioning. If not available, puncture and dispose in a sanitary landfill.
