- c. Delete the statement, "Treating Capacity: Contact Carbon Activated Corporation," from the product labeling.
- d. Revise the "Container Label Disposal" statement to read as follows:

Container Disposal: Fiber Drums with Liners:

"Completely empty liner by shaking and tapping sides and bottom to loosen clinging particles. Empty residue into applicable cable equipment. Then dispose of liner in sanitary landfill or by incineration if allowed by State and local authorities. If drum is contaminated and can not be used dispose of in the same manner."

The Confidential Statement of Formula dated June 15th, 2003, is acceptable.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA section 6(e). Your release for shipment of the product constitutes acceptance of these conditions.
