Proposed Amendment:

Label amendment to add conditions of sale and warranty and the directions for use in chlorine dioxide utilization systems other than for the treatment of municipal water system for Saf-T-Chlor Granular Sodium Chlorite (EPA Reg# 75757-3). The proposed label dated January 15, 2013 (pin punch 01/15/13).

Refer to the operator's manual for details. Install the cartridge as directed in the manual. Initiate chlorine dioxide production as described in the operator's manual. Use downstream monitoring to ascertain that chlorine dioxide levels in water are at the dosage level required / intended per EPA regulations.

FOR USE IN OTHER CHLORINE DIOXIDE UTILIZATION SYSTEMS

This product can be used in other chlorine dioxide utilization systems. These can be either gaseous dilutions or aqueous solutions. Follow the manufacturer's directions for use for that specific chlorine dioxide generating system.

STORAGE AND DISPOSAL
