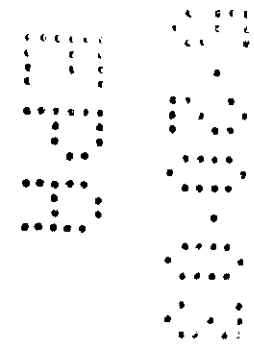

### To Operate Device:

1. Turn over device, remove both battery compartments' covers and install one AA battery in each compartment [(see illustration)]. Replace covers and turn device upright.
2. Remove one mosquito repellent mat from its wrapper and insert mat into the slot on the top of the device.
3. Slide the ON/OFF switch to the "ON" position. Wait a few moments and check to make sure the temperature sensor turns from black to red. This indicates the mat is heating and releasing the repellent.
4. Clip the device to your belt, pants/shorts waistband, purse strap or any other convenient location. Device may also be placed on a table, bench or other suitable surface away from food and sources of heat, ignition or moisture. To protect pets, clip on collar.

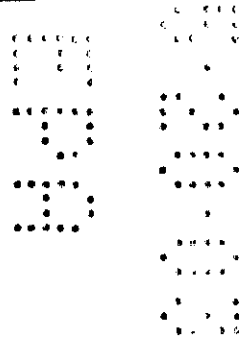
