- 3. The data listed in condition number 2 above must be submitted by the specified date and found to be acceptable. If any of the submitted data are found not to be acceptable, this registration will be subject to FIFRA sec. 6(e).
- 4. Make the labeling changes listed below before you release the product for shipment:
 - a. Add the phrase "EPA Registration Number 75799-1"
 - b. Revise the formulation statement to read as follows:

"For formulating use as wood preservative. This pesticide may only be used for the formulation of pesticide products used to pressure and thermal treatment of wood products for use in commercial/industrial setting such as utility poles, railroad ties and product used in an aquatic environment. Formulators must register their products with EPA under their own registrations and approved labels."

Note that the above statement must be located at the top of the front page, near the product's name.

c. Revise the first aid statement and its heading to read as follows: FIRST AID

IF IN EYES: Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing. Call a Poison Control Center or doctor for treatment advice.

In case of emergency call (insert toll-free emergency number). Have the product container or label with you when calling a Poison Control Center or doctor or going in for treatment.

- d. The signal "caution" must be listed in two places on the labeling, in the Precautionary statement heading and the keep Out Of Reach Of children Statement.
- e. The EPA Establishment No. must be listed on the label.
- 5. Submit three (3) copies of the final printed label prior to releasing this product for sale.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA sec. 6(e). Your release for shipment of the product constitutes acceptance of these conditions.
