Artichoke Plume moth [Platyptilia carduidactyla]

APPLICATION:

Deploy Exosex Stations containing an Exosex APM tray complete with lure at the rate of 10 stations per acre. Place the stations above the expected final canopy fixed to an end-looped L-shaped wire stake.

4 TIMING:

Deploy the station's prior to the onset of moth emergence or moth flights in the marketable crop. The Exosex APM travs are active for up to 90 days depending on the temperature. Replace Exosex APM trays at approximately 90 days but prior to

emergence of later moth flights.

DEPLOYMENT:

Exosex Station (packaged separately): The station is affixed horizontally to a stake and placed firmly into the ground. The station will align itself to the

prevailing wind direction.

Exosex APM trays: Open foil sachet and remove one of the trays with the lid uppermost. Remove plastic cover lid ensuring that it is the correct way up and slide it into the Exosex Station. To secure the tray position, push up the lower ends of the station so. that the tabs at both ends of the tray are secured into the holes in the station.

NOTES:

If the field borders another where artichoke plume moth is not controlled, migration of these moths can reduce the level of control achieved. To counteract this effect treat entire fields. Double the number of stations along such borders particularly for small fields. Alternatively treat this strip with insecticide. Monitor the occurrence of moths using weekly pheromone trap catches. If monitoring traps show a high infestation, consider a treatment of insecticide. Mating disruption systems are not designed to control high pest populations as a stand alone treatment, therefore supplementary applications are advised when Exosex APM is used to control high infestation levels. Where high pest levels occurred in the previous cropping season, a clean up insecticide application should be applied.
