The Antimicrobials Division (AD) has conducted a review of this request for its applicability under PRN 98-10 and finds that the action requested falls within the scope of PRN 98-10.

The label submitted with the application has been stamped "Notification" and will be placed in our records.

For use in the following sizes of residential humidifiers: Small portable humidifier units, Console humidifier units, Central humidifier units. For use in the following types of residential humidifiers: Ultrasonic, Cool mist (impeller), Evaporative, Steam vaporizer.

- 1. For every 2 gallons of water contained in the humidifier tank, use 1 AQUASTAT-HU cartridge [{descriptor}].
- 2. For best results, before using for the first time, it is recommended that you clean your humidifier according to the humidifier manufacturer's instructions to remove any buildup that may have accumulated.
- 3. After humidifier has been cleaned, drop one (1) AQUASTAT-HU cartridge [{descriptor}] per 2 gallons of water capacity into the humidifier water reservoir and fill tank with fresh water. For humidifiers with 2 tanks use 1 AQUASTAT-HU cartridge [{descriptor}] per tank.






