Empty all troughs, racks, automatic feeders, waterers, and other feeding and watering appliances.

Thoroughly clean all surfaces with soap or detergent and rinse with water. Saturate all surfaces with use solution (1/2 oz per gallon of water) for a period of 10 minutes.

Immerse all halters, ropes, and other types of equipment used in handling and restraining animals as well as forks, shovels, and scrapers used in removing litter and manure.

Ventilate buildings, vehicles, and other closed spaces. Do not house animals or employ equipment until treatment has been absorbed, set, or dried. 
