

#### **Treatment Procedure:**

- Place the required amount of FruitGard<sup>™</sup> into a suitable modified reactor. A modified 1. reactor can be the breathable sachets provided with the FruitGard<sup>™</sup>, or a blastic container (Clamshell, box, pail, etc.) with a porous cover (such as Tyvek®) that allows for the release of CIO<sub>2</sub> gas.
