

- The front panel of the label must include the ingredient Statement
- Delete the phrases "the natural mineral Purifier", Natural Minerals, and "the natural way" from the label wherever they appear on the label. Use of the term "Natural" on a pesticide label is not allowed as it is considered to be an implied safety claim. As purifier products are required to be registered and are different from swimming pool products you are not permitted to use this term in association with your registration. Pesticides purifier products that treat water that is unfit for human consumption to make it fit for human consumption.
- 3. All reference to "bacteria" on the label must be qualified by adding the phrase "eliminates bacteria at lower levels of chlorine (i.e., 0.5 ppm of chlorine)."
- 4. The front panel generally includes the EPA Registration No. and the EPA Establishment number.
- 5. The front panel must include the signal word "DANGER" the "Keep Out Of reach Of Children" statement, and the statement "see back panel for additional precautionary statements."
- 6. The first aid statement must appear on the front panel of the label.
- 7. Change the "*if Swallowed*" statement to read:
 - IF SWALLOWED: Call a poison Control Center or doctor immediately for treatment advice. Have person Sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a Poison Control Center or Doctor. Do not give anything by mouth to an unconscious person.
 - Note to Physician: Probable mucosal damage may contraindicate use of gastric lavage.
 - Have product container or label with you when calling a Poison Control Center or doctor for treatment advice.
- 8. Include the following information immediately below the ingredient statement:

CAS #7758-99-8 Cooper As Metallic Not Less Than 25% 0.51-LBS. Net Weight (233 Grams)

9. Include the following information on the back/side panel of the label: Precautionary Statement Hazard to Humans and Domestic Animals Keep Out Of Reach Of Children

DANGER: Corrosive. Causes irreversible eye damage Harmful if wallowed. Do not get in eyes or on clothing. Wear goggles, face shield, or safety glasses. Wash thoroughly with soap and water after handling and before eating, drinking, chewing gum, using restroom or using tobacco. Remove and contaminate clothing before reuse.

- Include the following headings before the start of the label use directions: Directions for Use
 It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.
- 11. Please note that the minimum type size for pesticide product labels is 6 Bodoni points. Ensure that no text on the label is below this point size.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA sec.6 (e). Your release for shipment of the product constitutes acceptance of these conditions.

Submit two (2) copies of the revised labeling bearing the labeling revisions listed above. A stamped copy of the label is enclosed for your records.



PoolRx and PoolRx Extreme:

Step 1: Start with a Clean Filter

Step 2: Place PoolRx Unit into Skimmer for the first 6 hours or until minerals have completely dissolved

Step 3: Take PoolRx Unit out of Skimmer and Place in the Pump Basket. (for maximum water flow over unit)

Step 4: Set required Chlorine Level

* Note: If you already have a low reading of chlorine (0.2-1.0ppm) you do not need to shock it. Maintain a 0.5-1.0ppm of chlorine for residential pools and 1.5-2.0ppm of chlorine for commercial pools. With PoolRx minerals in the water, it will take less chlorine to obtain your perferred chlorine level.

FIRST AID AND PRECAUTIONARY DETAILS

FIRST AID: Have product container or label with you when calling a poison control center or doctor, or going for treatment.



CARTRIDGE FILTER

OPTION 1 Remove Cartridge element from your filter and then place PoolRx unit in the skimmer. Allow 24 hours for minerals to dissolve and circulate in your pool. Put the cartridge element back in filter after 24hours. Take PoolRx unit out of skimmer and place it in the pump basket. (for maximum water flow).

OPTION 2 Place unit in Skimmer basket for first 24 hours, this give the minerals more time to dissolve and get through the filter, If pressure goes up for a few hours don't be alarmed minerals will dissolve through filter.

TIP If after a week the pressure is up, rinse the filter in the pool so no minerals are lost.

DE FILTER


