Based on your response to the 1,2-Benzisothiazolin-3-one RED, the EPA has reregistered this product subject to the comments recorded in the succeeding paragraph. Reregistration under this section does not eliminate the need for continual reassessment of pesticides. The EPA may require submission of data at any time to maintain the registration of the subject product.

b. Per the acute toxicity review and the Label Review Manual (7-4), the signal word section must be revised to read;

"DANGER POISON

[Inset skull and crossbones symbol]

- c. Per the acute toxicity review, the heading "IF SKIN IRRITATION OR DERMAL EXPOSURE" in the first aid statements must be revised to read "IF ON SKIN OR CLOTHING".
- d. The Agency recommends that additional text be added to the Note to Physician that addresses acute dermal toxicity and eye and skin irritation concerns.
- e. Per the acute toxicity review, the Hazards to Humans and Domestic Animals must be revised to read:

"DANGER

Fatal if absorbed through skin. Corrosive. Causes irreversible eye damage. Causes skin burns. Do not get in eyes, on skin, or on clothing. May be fatal if inhaled. Do not breathing vapor or spray mist. Harmful if swallowed. Avoid contact with skin, eyes or clothing. Prolonged or frequently repeated skin contact may cause allergic reactions in some individuals. Wear goggles or face shield, coveralls worn over long-sleeved shirt and long pants, socks chemical-resistant footwear, chemical-resistant gloves made of barrier laminate, butyl, nitrile, or neoprene rubber, polyvinyl chloride or viton, a respirator with an organic-vapor removing cartridge with a prefilter approved for pesticides (MSHA/NIOSH approval number prefix TC-23C), or a canister approved for pesticides (MSHA/NIOSH approval number prefix TC-14G), or a NIOSH approved respirator with an organic vapor (OV) cartridge or canister with any N, R, P or HE prefilter."

f. The Agency recommends that the following User Safety Requirements text be added to the label:

"Follow manufacturer's instructions for cleaning/maintaining PPE. If no such instructions for washables exist, use detergent and hot water. Keep and wash PPE separately from other laundry.

Discard clothing and other absorbent materials that have been drenched or heavily contaminated with this product's concentrate. Do not reuse them."

g. Per the acute toxicity review, the following User Safety Recommendations must be added to the label:

"User Safety Recommendations

User should wash hands before, eating, drinking, chewing gum, using tobacco, or using the toilet.

User should remove clothing/PPE immediately if pesticide gets inside. Then wash thoroughly and put on clean clothing.

User should remove PPE immediately after handling this product. As soon as possible, wash thoroughly and change into clean clothing."

h. Per the product chemistry review, the storage and disposal section must be revised to comply with PR Notice 2007-4.

i. Under the STORAGE AND DISPOSAL heading, the word "PROHIBITIONS" must be deleted. The statement "Do not contaminate water, food, or feed by storage or disposal. Open dumping is prohibited." Needs to be revised to read: "Do not contaminate water, food, or feed by storage or disposal." This statement must be placed in the beginning of the section in accordance with 40 CFR 156.10 and the PR Notice 83-3.

2. For additional labeling clarity and consistency, please refer to the enclosed EPA reviews.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA sec.6(e). Your release for shipment of the product constitutes acceptance of these conditions.

Submit two (2) copies of the revised labeling bearing the labeling revisions listed above. A stamped copy of the label is enclosed for your records.

FIRST AID

For protection against bacterial attack, a concentration within the range 0.02-0.25% PROMEX™ 20D is almost invariably sufficient.
