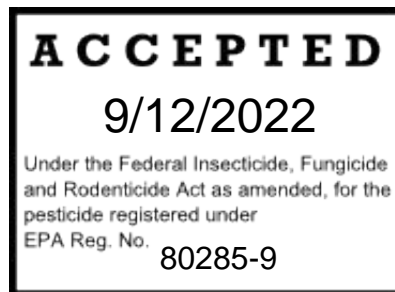

### GENERAL INFORMATION

**PRODUCT:** Use levels given for the various applications indicate the appropriate levels of Promex™ IPBC 40D for the particular application. All suggestions are given in percentage by weight and refer to the product Promex™ IPBC 40D.

**USE:** In order to determine the most cost-effective use level for Promex™ IPBC 40D in a given use, field trials are suggested.

### GENERAL PRECAUTIONS AND RESTRICTIONS

Do not apply this product in a way that will contact workers or other persons. Promex™ IPBC 40D is not to be used in formulations for materials that come in contact with food.

### APPLICATION INSTRUCTIONS

**PAINTS AND STAINS:** Use 0.4-1.2% or 4-12 pounds of Promex™ IPBC 40D per one hundred gallons. For hot, humid areas use up to 20 lbs. For interior paints use 0.1-0.4% (1-4 lbs.). For wood protective stains, use 0.8-1.2% (8-12 pounds) of Promex™ IPBC 40D.

**PLASTICS:** Use in PVC plastics, such as shower curtains, tarpaulins, umbrellas at a level of 0.5-2.5%.

**WOOD:** For above ground use only at rates of 0.5-2.0%, depending on protection to prevent growth of mildew, sapstain and wood decay organisms. For sapstain and mold control, use 0.5% within 24 hours of cutting. For decay organisms in millwork, use 0.5%. Do not apply to wood surfaces that come in contact with food.

**TEXTILES:** Use 0.1-1.0% for coatings or dyes. Not for use in fabrics for human wear.

**PAPER COATINGS: For use in non-food contact coatings only.**

Use in aqueous and solvent-based coatings applied to paper at 0.05-0.75%.

**CANVAS AND CORDAGE:** Use 0.5-2.0%.

**ADHESIVES, CAULKS, GROUTS and SEALANTS:** Use 0.05-0.2%.

**INKS:** Use 0.05-3.0%.

**DISPERSED PIGMENTS:** For use in the manufacture and storage of dispersed pigments, extender slurries and colorants at 0.23-2.1%.

### **STORAGE AND DISPOSAL**

**PESTICIDE STORAGE:** This product has the tendency to crystallize at low temperatures. Storage temperatures below 90°F (32°C) and above 32°F (0°C) are suggested.

Triple Rinse as follows: Empty the remaining contents into application equipment or a mix tank. Fill the container ¼ full with water. Replace and tighten closures. Tip container on its side and roll it back and forth, ensuring at least one complete revolution, for 30 seconds. Stand the container on its end and tip it back and forth several times. Turn the container over onto its other end and tip it back and forth several times. Empty the rinsate into application equipment or a mix tank or store rinsate for later use or disposal. Repeat this procedure two more times. Then offer for recycling if available, or reconditioning if appropriate, or puncture and dispose of in a sanitary landfill or by incineration.

*[Use the following for product sold in refillable containers:]*

Refillable container. Refill this container with pesticide only. Do not reuse this container for any other purpose.
