The amendment referred to above, submitted in connection with registration under section (3) of the Federal Insecticide, Fungicide and Rodenticide Act as amended is acceptable provided the following conditions are met:

- Submit frozen storage stability data (OPPTS 860.1380) demonstrating the stability of residues of tetraconazole per se in/on grape (236 days) and T, TA, and TAA residues in/on grape (236 days), grape juice (64 days), and raisin (68 days) due January 1, 2011.
- Submit an immunotoxicity study (OPPTS 870.7800) -- due January 1, 2011.
- Submit an acute neurotoxicity study (OPPTS 870.6200) due January 1, 2010.
- Submit a subchronic neurotoxicity study (OPPTS 780.6200 due January 1, 2011.
- Comply in the timeframe specified with the future Agency data call-in for all triazole-derived active ingredients.
- Submit one copy of the final printed label before the product is released for shipment.
