For large areas where aircraft or power driven sprayers are used to apply the spray, follow the specific crop use rates in the tables below. Apply with sufficient water to get thorough foliage coverage, 3 to 10 gallons of water per acre for aircraft sprayers and 10 to 50 gallons of water per acre for ground driven spray equipment.

Adjust rates and dosages for foliar applications of Incite depending on the climatic region, soil type and fertility. For best results, increase the frequency of application; additional applications can be made as required.

Compatibility Test for Tank Mix Components

CytoTek Enterprises, Inc. does not assume responsibility for unexpected results when tank mixing with Incite. Conduct a jar test before tank mixing to ensure compatibility of Incite with other pesticides, or fertilizers if the tank mix combination has not been used previously. In addition, apply the mixture to a small area or small number of plants prior to large-scale treatments to ensure the mixture does not result in phytotoxicity.

To test for compatibility, in a small jar, mix a small amount (0.5 to 1 quart) of spray, combining all tank mix ingredients in the same ratio as the anticipated use. If any indications of physical incompatibility develop, do not use this mixture for spraying. These indications usually appear within 5 to 15 minutes after mixing and include observations such as development of a precipitate or surface oil or thick (clabbered) texture. Do not use any spray solution that could clog spray nozzles. CHEMIGATION

Apply this product only through drip (trickle) irrigation systems. Do not apply this product through any other type of irrigation system.

For sod production, parks, golf courses, athletic fields and home lawns, begin Incite applications at the initial growth stage and continue throughout the season at 2 to 4 week intervals. Additional applications can be made after periods of heavy traffic use or high stress. Spray newly applied sod to help new root growth and root penetration of soil. A late season spray will help improve resistance to winter kill and frost damage. For seed production, apply 4-8 fluid ounces Incite per acre just prior to spear formation.

DECIDUOUS OR CONIFEROUS TREES AND SHRUBS:

Make the first Incite application early in the season at the initiation of new growth, applying 4-8 fluid ounces Incite per acre. Follow with two sprays of 4-8 fluid ounces Incite per acre at 14 to 21 day intervals during the growing season. A late season spray will help improve resistance to winter kill and frost damage, although it is not a substitute for standard winter protection. A late season application will help Christmas trees retain their dark green color after cutting.

FIELD ORNAMENTALS:

Start the season by applying 4-8 fluid ounces Incite per acre at the early leaf stage. Continue with regular applications of 4-8 fluid ounces Incite per acre every 2 weeks.

GREENHOUSE ORNAMENTALS:

Apply to soil at transplant or start by spraying the foliage to run off point within 10 days of transplant or emergence at the rate of 4-8 fluid ounces Incite per 100 gallons of water. Continue with regular applications of 4-8 fluid ounces Incite per acre every 2 weeks.

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal.

PESTICIDE STORAGE: Store Incite in its original container in a cool, dry locked place out of the reach of children and out of direct sunlight.
