GENERAL INFORMATION

Incite is a blend of bio-stimulants containing synthetic and naturally occurring plant growth regulators and plant hormones. The blend of Cytokinin (as Kinetin), Gibberellic Acid, and Indole-3-Butyric Acid stimulates plant growth and development, enhances cell division, cell differentiation, cell enlargement, root growth, and nutrient utilization; these effects are expected to promote:

- Increased yields
- Increased fruit set
- Improved resistance to environmental stress
- Earlier maturity
- Improved crop quality

Use Incite on the following food and non-food crops:

FIELD CROPS:

ALFALFA, CLOVER, CORN (Includes Field Corn and Popcorn), COTTON, LUPINE, PEANUTS, RICE, SORGHUM, MILO, SOYBEANS, SUGAR BEETS, WHEAT

FRUITS:

Seed Treatment:

For coating seeds prior to planting, apply Incite at the rate of 1-4 fluid ounces per 100 pounds of seeds.

APPLICATION INSTRUCTIONS

Do not use treated seed for food or feed purposes or process for oil. Treat only those seeds needed for immediate use, minimizing the interval between treatment and planting. Do not store excess treated seeds beyond planting time.

Irrigation/Chemigation

Apply Incite to stimulate root growth through irrigation into the soil surrounding plant roots. See tables below for application rates and timing.

Foliar Spray:

Incite is most effective when used as part of a regular foliar nutritional spray program and can be applied with any standard fertilizer or crop protection spray system. For best results, apply the foliar spray mixture as a fine mist, with low fluid velocity until the foliage is wet. Common surfactants can be used.

For large areas where aircraft or power driven sprayers are used to apply the spray, follow the specific crop use rates in the tables below. Apply with sufficient water to get thorough foliage coverage, 3 to 10 gallons of water per acre for aircraft sprayers and 10 to 50 gallons of water per acre for ground driven spray equipment.

Adjust rates and dosages for foliar applications of Incite depending on the climatic region, soil type and fertility. For best results, increase the frequency of application; additional applications can be made as required.

Compatibility Test for Tank Mix Components

CytoTek Enterprises, Inc. does not assume responsibility for unexpected results when tank mixing with Incite. Conduct a jar test before tank mixing to ensure compatibility of Incite with other pesticides, or fertilizers if the tank mix combination has not been used previously. In addition, apply the mixture to a small area or small number of plants prior to large-scale treatments to ensure the mixture does not result in phytotoxicity.

To test for compatibility, in a small jar, mix a small amount (0.5 to 1 quart) of spray, combining all tank mix ingredients in the same ratio as the anticipated use. If any indications of physical incompatibility develop, do not use this mixture for spraying. These indications usually appear within 5 to 15 minutes after mixing and include observations such as development of a precipitate or surface oil or thick (clabbered) texture. Do not use any spray solution that could clog spray nozzles. Follow the most restrictive of all precautions and limitations on this label and labels of other pesticide products used in the tank mixture with Incite.

CHEMIGATION

Apply this product only through drip (trickle) irrigation systems. Do not apply this product through any other type of irrigation system.

Crop injury, lack of effectiveness, or illegal pesticide residues in the crop can result from non-uniform distribution of treated water.

If you have questions about calibration, you should contact State Extension Service specialists, equipment manufacturers, or other experts.

Do not connect any irrigation system (including greenhouse systems) used for pesticide application to a public water system unless the pesticide label-prescribed safety devices for public water systems are in place.

A person knowledgeable of the chemigation system and responsible for its operation or under the supervision of the responsible person, shall shut the system down and make necessary adjustments should the need arise.

Chemigation Systems Connected to Public Water Systems

Public water system means a system for the provision to the public of piped water for human consumption if such system has at least 15 service connections or regularly serves an average of at least 25 individuals daily at least 60 days out of the year.

Chemigation systems connected to public water systems must contain a functional, reduced pressure zone, backflow preventer (RPZ) or the functional equivalent in the water supply line upstream from the point of pesticide introduction. As an option to the RPZ, the water from the public water system should be discharged into a reservoir tank prior to pesticide introduction. There shall be a complete physical break (air gap) between the outlet end of the fill pipe and the top or overflow rim of the reservoir tank of at least twice the inside diameter of the fill pipe. The pesticide injection pipeline must contain a functional, automatic, quick-closing check valve to prevent the flow of fluid back toward the injection pump. The pesticide injection pipeline must contain a functional, normally closed, solenoid-operated valve located on the intake side of the injection pump and connected to the system interlock to prevent fluid from being withdrawn from the supply tank when the irrigation system is either automatically or manually shut down. The system must contain functional interlocking controls to automatically shut off the pesticide injection pump when the water pump motor stops, or in cases where there is no water pump, when the water pressure decreases to the point where pesticide distribution is adversely affected.

Systems must use a metering pump, such as a positive displacement injection pump (e.g., diaphragm pump) effectively designed and constructed of materials that are compatible with pesticides and capable of being fitted with a system interlock. Do not apply when wind speed favors drift beyond the area intended for treatment.

Drip (Trickle) Chemigation

- The system must contain a functional check valve, vacuum relief valve, and low pressure drain appropriately located on the irrigation pipeline to prevent water source contamination from backflow.
- The pesticide injection pipeline must contain a functional, automatic, quick-closing check valve to prevent the flow of fluid back toward the injection pump.
- The pesticide injection pipeline must also contain a functional, normally closed, solenoid-operated valve located on the intake side of the injection pump and connected to the system interlock to prevent fluid from being withdrawn from the supply tank when the irrigation system is either automatically or manually shut down.
- The system must contain functional interlocking controls to automatically shut off the pesticide injection pump when the water pump motor stops.
- The irrigation line or water pump must include a functional pressure switch which will stop the water pump motor when the water pressure decreases to the point where pesticide distribution is adversely affected.
- Systems must use a metering pump, such as a positive displacement injection pump, (e.g., diaphragm pump) effectively designed and constructed of materials that are compatible with pesticides and capable of being fitted with a system interlock.

When applying Incite via chemigation, use a pesticide supply tank. Prepare a suspension of Incite in a mix tank by filling the tank with ½ to ¾ the specified amount of water. Start mechanical or hydraudic agitation and slowly add the required amount of Incite. Complete the mix by adding the remaining volume of water.

The spray mixture must be continuously agitated during application.

Apply Incite continuously for the duration of the water application.

Use lower rates when product is diluted and applied in twenty gallons of water or less per acre.

Incite can be used in turf grass seed production, sod production, parks, golf courses, athletic fields and home lawns at a rate of 4-8 fluid ounces Incite per acre. For sod production, parks, golf courses, athletic fields and home lawns, begin Incite applications at the initial growth stage and continue throughout the season at 2 to 4 week intervals. Additional applications can be made after periods of heavy traffic use or high stress. Spray newly applied sod to help new root growth and root penetration of soil. A late season spray will help improve resistance to winter kill and frost damage. For seed production, apply 4-8 fluid ounces Incite per acre just prior to spear formation.

DECIDUOUS OR CONIFEROUS TREES AND SHRUBS:

Make the first Incite application early in the season at the initiation of new growth, applying 4-8 fluid ounces Incite per acre. Follow with two sprays of 4-8 fluid ounces Incite per acre at 14 to 21 day intervals during the growing season. A late season spray will help improve resistance to winter kill and frost damage, although it is not a substitute for standard winter protection. A late season application will help Christmas trees retain their dark green color after cutting.

FIELD ORNAMENTALS:

Start the season by applying 4-8 fluid ounces Incite per acre at the early leaf stage. Continue with regular applications of 4-8 fluid ounces Incite per acre every 2 weeks.

GREENHOUSE ORNAMENTALS:

Apply to soil at transplant or start by spraying the foliage to run off point within 10 days of transplant or emergence at the rate of 4-8 fluid ounces Incite per 100 gallons of water. Continue with regular applications of 4-8 fluid ounces Incite per acre every 2 weeks.

STORAGE AND DISPOSAL
