This product is for use in ClorDiSys Solutions, Inc. Cloridox-GMP Sterilization System ONLY and must be used by trained personnel. For proper generation and application of chlorine dioxide, you must follow the instructions in the Cloridox-GMP Sterilization System Operations Guide.
