#### SACRAMENTO Dear Ms. Hollis:

Enclosed with this letter you will find the following in support of a notification to add alternate brand names for the above referenced product:

- 1) Notification form;
- 2) One (1) copy of the revised label with the alternate brand names highlighted in redline.

This label notification is to make the following label changes:

- a. Add the alternate brand name "Shake-Away® Coyote Urine Granules."
- b. Correct a math error the Directions for Use section under "Coverage" (page 3). The previous label incorrectly listed "(3800 linear feet for 12 lb bottle)." The correct calculation is "(5760 linear feet for 12 lb bottle)." This correction was previously made on the other labels from Shake-Away for similar products (80917-4 and 80917-5).
- c. Add marketing text in the form of a table that lists the three Shake-Away animal repellent products that are available. The table provides the product name, EPA Registration Number and labeled pests.
