Application Directions:

- Shake-Away® Deer Repellent 90-Day Pack(s) (kit) contains: (One) (Four) Shake-Away® Deer Repellent 90-Day Pack(s), (one) (two) twist tie(s) for hanging.

Hanging -

(Directions for one 90-Day Pack) Hang on (pack) (product name) to cover an area with an 8' radius *see diagram). For best results on larger areas, hang on (pack) (product name) every 16' around the perimeter of your garden or flowerbed, ensuring there is a pack on every outside corner. Suspend each pack approximately 1' to 4' above the ground depending on the height of the plant, shrub or tree to be effected. (See diagram.) **DO NOT OPEN PACKS OR DISPERSE CONTENTS.**

(Directions for multiple 90-Day Packs) Hang one (pack) (product name) every 10 to 20 feet around your garden or flowerbed perimeter, ensuring there is a pack on every outside corner. Suspend each pack approximately 2 to 4 feet above ground. For best results on isolated trees

Replacing -

To create a repellent barrier, apply this product to soil, ground cover, bark mulch, perimeter vegetation and non-food vegetation adjacent to food plants.

General use in yards, around gardens -

Apply Shake-Away® Deer Repellent twice a week for the first two weeks, then twice a month for maintenance. Sprinkle Shake-Away® Deer Repellent lightly in and around areas where animals are causing damage, or in areas you want to protect.
