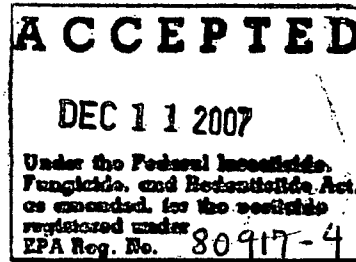

To create a repellent barrier, apply this product to soil, ground cover, bark mulch, perimeter vegetation and non-food vegetation adjacent to food plants.

**General use in yards, around gardens -**

Apply Shake-Away® Critter Repellent Granules twice a week for the first two weeks, then twice a month for maintenance. Sprinkle Shake-Away® Critter Repellent Granules A lightly in and around areas where animals are causing damage, or in areas you want to protect.

**In attics, basements, garages and sheds –**
