- 2) One (1) copy of the revised label with all changes highlighted in redline.

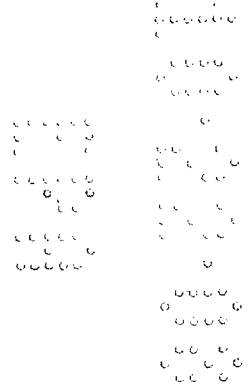
This label notification is to make the following label changes:
